PLACEMENT COMPLETED

Further to an announcement made on 23 May 2011, Verus Investments Limited (Verus) is pleased to announce completion of a private placement of 132 million shares at a price of 1 cent each and 66 million listed options exercisable at 2 cents expiring on 31 March 2012, raising a total of \$1.32 million (less costs).

The funds raised will enable Verus to meet its farm-in obligations for its new investment in the Lyons Point Prospect in Louisiana and for working capital and general corporate purposes.
