Issue of Incentive Equity to Key Personnel

The Board of Digital CC Limited (trading as **digitalBTC**, ASX:**DCC** and “the **Company**”) has resolved to issue 1,713,978 ordinary shares to key personnel of the Company, as part of their remuneration packages. This incentive equity program was put in place to incentivise performance of the Company’s key personnel outside of the Board of Directors, and form a key plank of the Company’s personnel retention strategy for their ongoing service to the Company.
