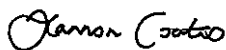
DigitalX Ltd (ASX: DCC) – Request for trading halt

Pursuant to ASX Listing Rule 17.1, DigitalX Ltd (**Company**) requests an immediate trading halt be granted by ASX in respect of its ordinary shares.

In accordance with ASX Listing Rule 17.1, the Company provides the following information:

1. **Reason for trading halt** – The trading halt is requested pending an update on the completion of the issue of tranche 1 of the convertible notes, announced on 20 March 2017.
2. **Duration of the trading halt** – the Company anticipates that the trading halt will remain in place until the earlier of such time as it makes an announcement to the market in relation to the completion of the issue of tranche 1 of the convertible notes and the commencement of trading on Tuesday 28 March 2017.
3. **Termination of the trading halt** – the Company anticipates that the trading halt will cease upon it making an announcement in relation to completion of the issue of tranche 1 of the convertible notes.
4. **No reason** – the Company is not aware of any reason why the trading halt should not be granted.
5. **Further information** – the Company is not aware of any other information to inform the market about the trading halt.
