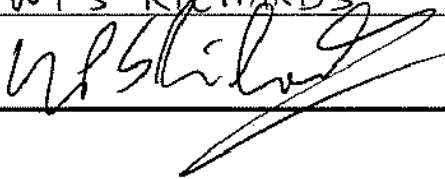

DIRECTIONS
