AMENDED APPENDIX 3Y – MR ANDREW TSANG

On 6 March 2009, at 18:33 EDST, the Company lodged a Change of Director's Interest Notice for transactions completed by Mr Andrew Tsang (both direct and indirect) for the period 4-6 March 2009. The transactions detailed in the Notice were as advised by Mr Tsang's stockbroker after market close on 6 March 2009 and represented the most up to date information.

It has today been brought to the Company's attention by Mr Tsang's stockbroker that an error occurred on 6 March 2009 wherein 100,000 ordinary shares purchased by Mr Tsang's spouse were erroneously booked against another client's account. The matter only came to the attention of the Stockbroker when the order was unable to settle, following which the shares were correctly entered against Chunxiang Zeng.

The Company is acting on this advice immediately by issuing the attached amended Appendix 3Y to replace the Appendix 3Y lodged on 6 March 2009. Please note that it covers the same period being 4-6 March 2009, but now includes the 100,000 ordinary shares purchased by Chunxiang Zeng on 6 March 2009.

All directors were advised of a trading blackout period which commenced effective 7 March 2009.

The company continues to liaise with its directors on a regular basis to be assured that all notifiable interests are released to market in a timely manner and that directors remain aware of the Company's disclosure responsibilities under ASX Listing Rule 3.19B.
