Consequently, cash at end of September 2023 for the JV totalled \$5.9M, giving total cash of \$17.8m being held by the Company. Also post the September quarter, the JV received the 2nd tranche investment of \$24m from Sibelco giving a total cash of \$41.8m being held by the Company (Refer ASX (Refer ASX announcement on 17 October 2023).
