ISSUE OF SHARES

Eastern Iron has exercised its option to acquire a 100% of the Nowa Nowa Iron Project located in eastern Victoria as announced to ASX today. Under the terms of the option agreement Eastern Iron is required to pay \$100,000 and allot one million shares.
