ASX Announcement

Marenica Energy Raises \$356,000

Further to the announcement of 9 April 2015, Marenica Energy Limited (ASX:MEY) ("the Company") wishes to advise that the Company has today completed the placement of 1,500,000 fully paid ordinary shares to Hong Kong based Chinese company, Mingsun Technology Co Limited. The shares were issued at an issue price of \$0.2373 per share raising a total of approximately \$356,000 for the Company. The placement provides substantial working capital to Marenica for the further development and commercialisation of its ***U-pgrade™*** process.

A further 269,603 fully paid ordinary shares were issued in lieu of a portion of salary/fees owed to Marenica's CEO Mr Murray Hill and consultant to the Company Mr John Sestan as announced to ASX on 13 February 2015.
