Section 708A Cleansing Statement

Elementos Limited (ASX: ELT; ACN 138 468 756)(the **Company**) advises that it has, today, issued 139,722,687 fully paid ordinary shares in the capital of the Company (**Shares**) and 84,060,608 options to acquire Shares (**Options**) in accordance with the recently announced share purchase plan (**SPP**), private placement, director incentive issue and debt forgiveness that were the subject of the resolutions approved at the Company's annual general meeting held on 16 November 2020, as per the ASX Appendix 2A lodged today.

5,000,001 Shares were issued pursuant to the SPP offer document. A further 134,722,686 Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act, and are issued subject to the "Cleansing Statement" below.
