EQUINOX RESOURCES LIMITED – TRADING HALT REQUEST

Pursuant to ASX Listing Rule 17.1, Equinox Resources Limited (ASX: EQN) (“Equinox” or “the Company”) requests that an immediate trading halt be put on its securities.
