**YOUR OPTIONS TO ACQUIRE FULLY PAID EMU NL SHARES AT \$0.10 PER SHARE  
EXPIRE ON 30/03/17 AND ARE NOW ELIGIBLE FOR TRADING ON ASX**

We are writing to you as a registered holder of 30/03/17 options in EMU NL to inform you that **your options are now eligible for trading on ASX** and to remind you that the options will expire at 5:00pm (AWST) on 30/03/17.

Your option holding may be exercised in whole or in part by payment of \$0.10 for each option by no later than 30/03/17. If payment is not received (in cleared funds) by 5:00pm (AWST) by 5PM AWST 30/03/17 the options will lapse and your rights under the options will cease at that time.
