

Completion of Share Purchase Plan

Enterprise Metals Limited (“Enterprise” or “the Company”, ASX: ENT) is pleased to announce that its recent Share Purchase Plan (“SPP”), which closed on 21 March 2016, has raised \$216,000. The SPP provided an opportunity to existing eligible Shareholders to subscribe for new fully paid ordinary shares (“New Shares”) in the Company at an issue price per New Share of 1.8 cents representing a discount of approximately 20% to the volume weighted average market price of 2.3 cents per share over the last 20 days on which sales in Enterprise shares were recorded prior to announcement of the SPP on 17 February 2016.

The funds raised through the SPP will be largely directed towards further continued exploration for copper and gold at the Company’s Doolgunna Project, newly granted tenements at its Yalgoo Project and for working capital purposes.
