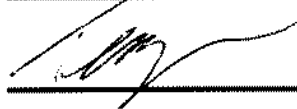

DIRECTIONS

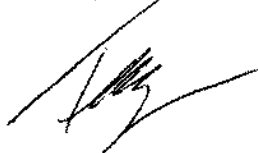
