US DOI Panel Contract Selection For SFFR-6 Tactical Repeater

Etherstack is pleased to announce that it's SFFR-6 P25 Tactical Repeater (aka the "Go Box") has been selected for inclusion on a US Department of Interior (DOI) contract for the supply of radio equipment including equipment that conforms to the APCO P25 digital radio standard.

The contract is effectively a blanket purchase agreement until 30th September 2022, that allows the US DOI and certain other US Federal and State agencies to purchase approved equipment from a select list of manufacturers, including Etherstack. The contract does not specify or guarantee purchase dates or quantities from any particular named supplier but is a major procurement vehicle used by the US federal government for this type of equipment.

Mr Doug Chapman, Etherstack's VP North America said, "The inclusion of the SFFR-6 Tactical Repeater on the DOI contract after a rigorous testing and assessment process will greatly increase US sales opportunities by allowing multiple agencies to purchase units from the approved list".

The SFFR-6 P25 Tactical Repeater was also one of two Etherstack products selected by the UK Ministry of Defence for inclusion on the UK Defence and Security Organisation (DSO) capability showcase at DSEI 2017 in London late last year. DSEI is one of the world's largest defence and security tradeshows. The other Etherstack product selected for DSEI was Etherstack's new IVX P25 PTT over Satellite in-vehicle repeater for which the customer received it's initial orders in the past 6 months.

The SFFR-6 has now been deployed for several years by emergency services, federal security and defence agencies internationally. Multiple agencies have made repeat orders for the devices.

David Deacon, Etherstack CEO said, "The Go Box is clearly the 'best in class' product of its type. The uptake has been very promising and the unit is gaining a positive reputation amongst its demanding client base. The successful adoption of the Go Box in policing, emergency services and defence sectors bodes well for our new innovative IVX product which is currently being deployed to lead clients."
