**NOTICE GIVEN UNDER section 708A(5) OF THE CORPORATIONS ACT**

This notice is given by Jadar Lithium Limited (“**Company**”) under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (“**Act**”).

On 13 August 2019 the Company issued 25,000,000 unlisted options without disclosure under Part 6D.2 of the Act.
