Exercise of Unlisted Options - Amended

FAR Limited (ASX: FAR) wishes to advise that it has issued a total of 1,000,000 fully paid ordinary shares upon the exercise of unlisted options.

An amended Appendix 3B for the issue of new shares is attached. The amendment is included in 6i of the attached form and now excludes the remaining capacity under rule 7.1A. FAR is no longer an eligible entity under rule 7.1A.

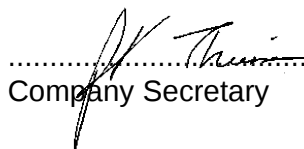
