### **Completion of FAR Limited's \$15 million Entitlement Offer**

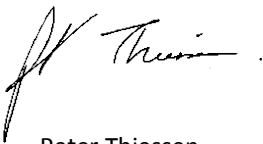

FAR Limited (ASX:FAR) (**FAR**) is pleased to advise that it has today completed the issue and allotment of 187,841,672 new fully paid ordinary shares in FAR (**New Shares**).

The New Shares were issued pursuant to a non-renounceable pro rata entitlement offer announced on 23 October 2015 (**Entitlement Offer**) which closed on 18 November 2015. Under the Entitlement Offer, eligible shareholders were offered 1 new fully paid ordinary share in FAR for every 17 shares held at an issue price of \$0.08 (8 cents) per share.

FAR now has 3,693,650,099 fully paid ordinary shares on issue following the issue and allotment of New Shares under the Entitlement Offer.
