Release of Securities from ASX Imposed Escrow

Frontier Digital Ventures (ASX: FDV), a leading operator of online classifieds businesses in frontier markets across the globe, today announced the impending release of ordinary shares from mandatory escrow.

As disclosed in the company's initial public offering (IPO) replacement prospectus dated 9 August 2016 (**FDV Prospectus**), certain pre-IPO shareholders were required to enter into mandatory escrow restriction agreements whereby ordinary shares held at the time of the IPO were subject to escrow restrictions until the end of the relevant mandatory escrow period.

Pursuant to ASX Listing Rule 3.10A, FDV announced that 5,735,088 ordinary shares will be released from mandatory escrow on 6 December 2016.

The release of ordinary shares from mandatory escrow in December 2016 will not affect any escrowed shares held by the following shareholders under their respective mandatory escrow restriction agreements:
