Answer: No. The Company has shown positive margins on sales to date, and with significant orders now in hand and the production capacity to substantially increase sales, the Company anticipates a material increase in net operating cash flows over the June 2024 quarter and future quarters.	

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: No. The Company has arranged a factoring facility (see item 7.6 above) for its major orders and to support its liquidity position, and combined with increasing sales, the Company is of the view that these arrangements will provide sufficient cash for the Company to fund its operations.

Answer: Yes. The Company continues to generate increasing sales and production at positive margins to enable the Company to continue its operations and to meet its business objectives.
