H1 FY26 - Key Themes

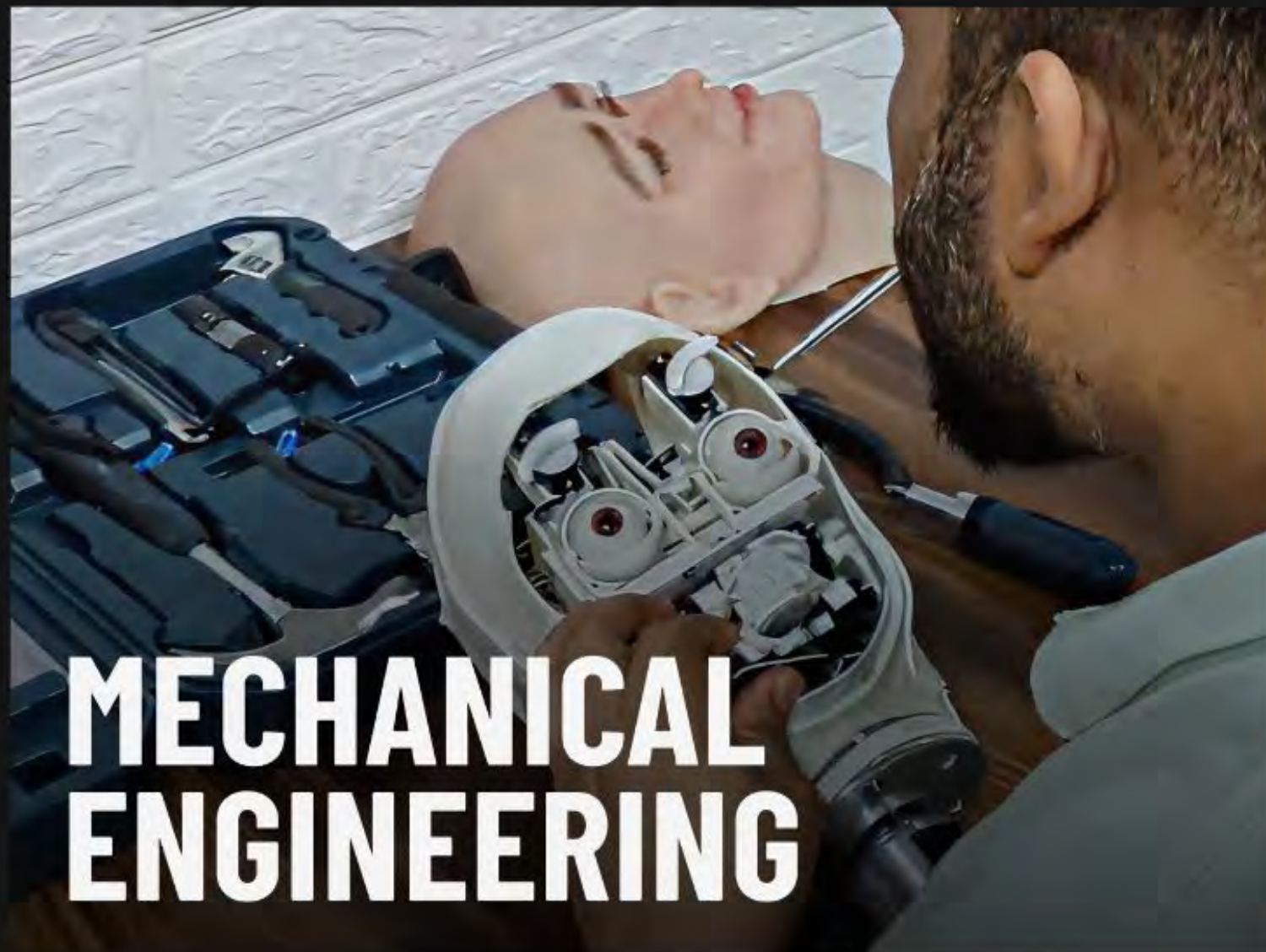
Mixed operating performance for the half. Escrow and Loadshift grew strongly, offset by lower activity in Freelancer. Reported revenue fell 12.1% in AUD but was broadly flat in USD, the group's main operating currency, at 72.4% of revenue.

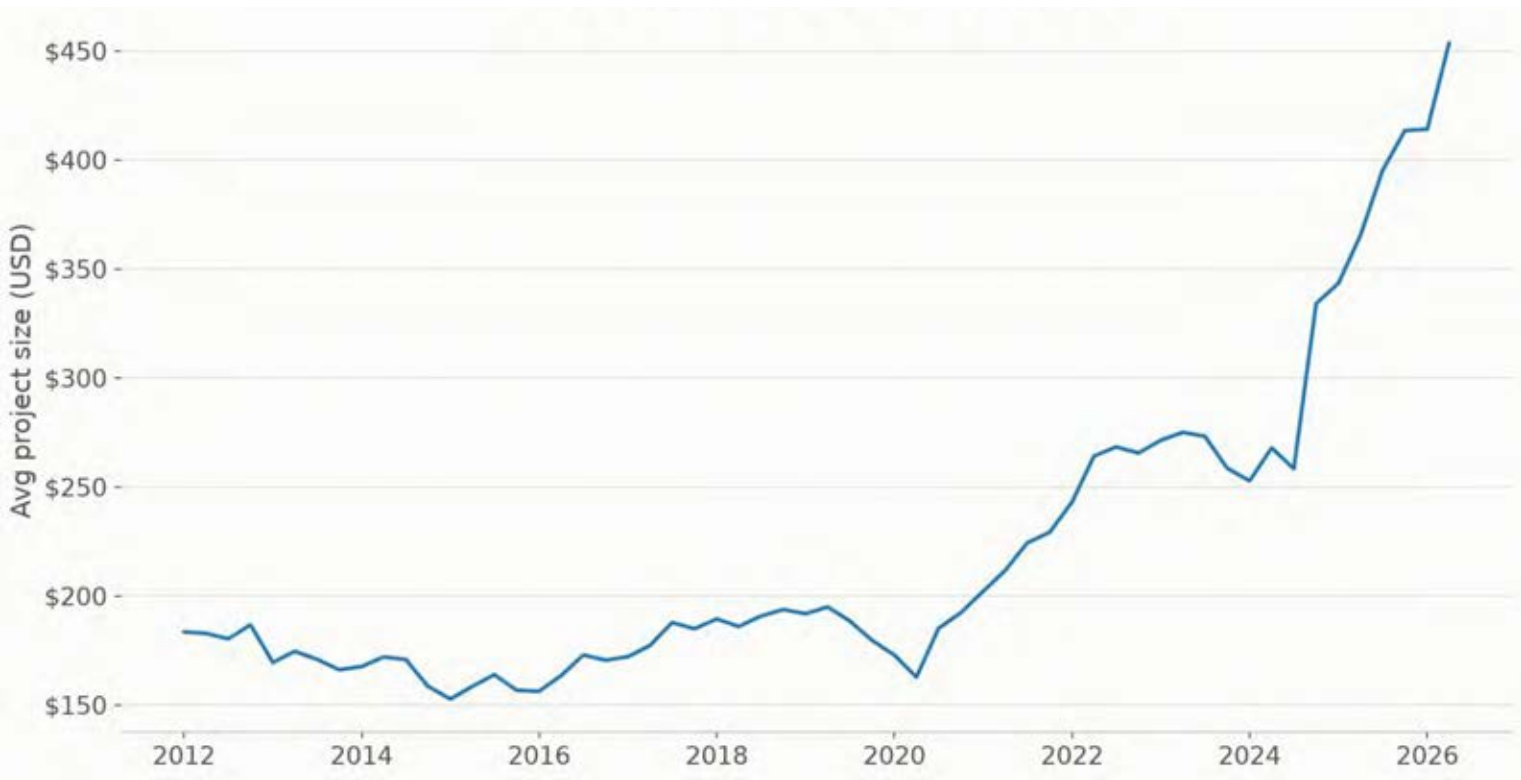

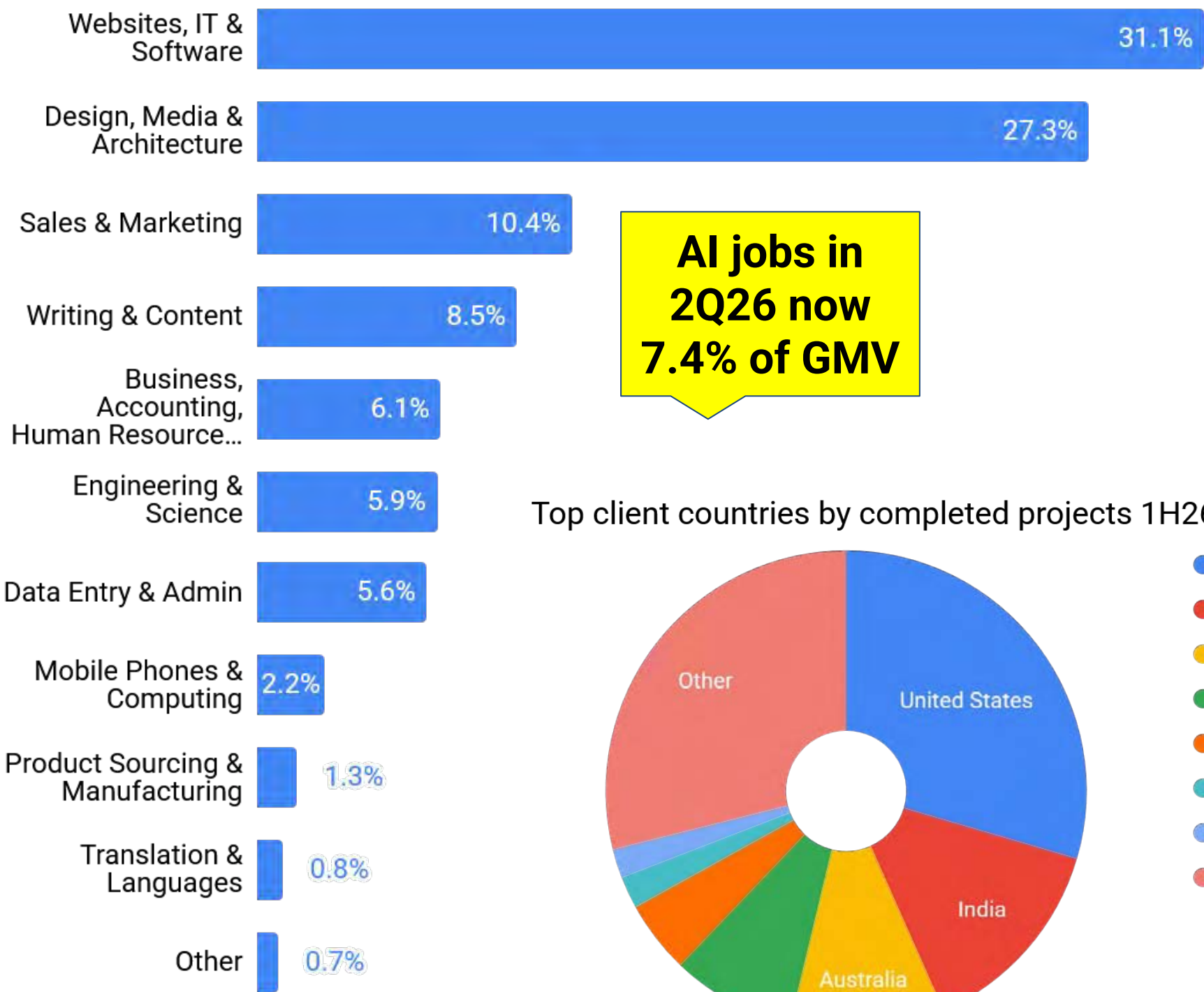
Marketplace dynamics largely unchanged FY25 to 1H26

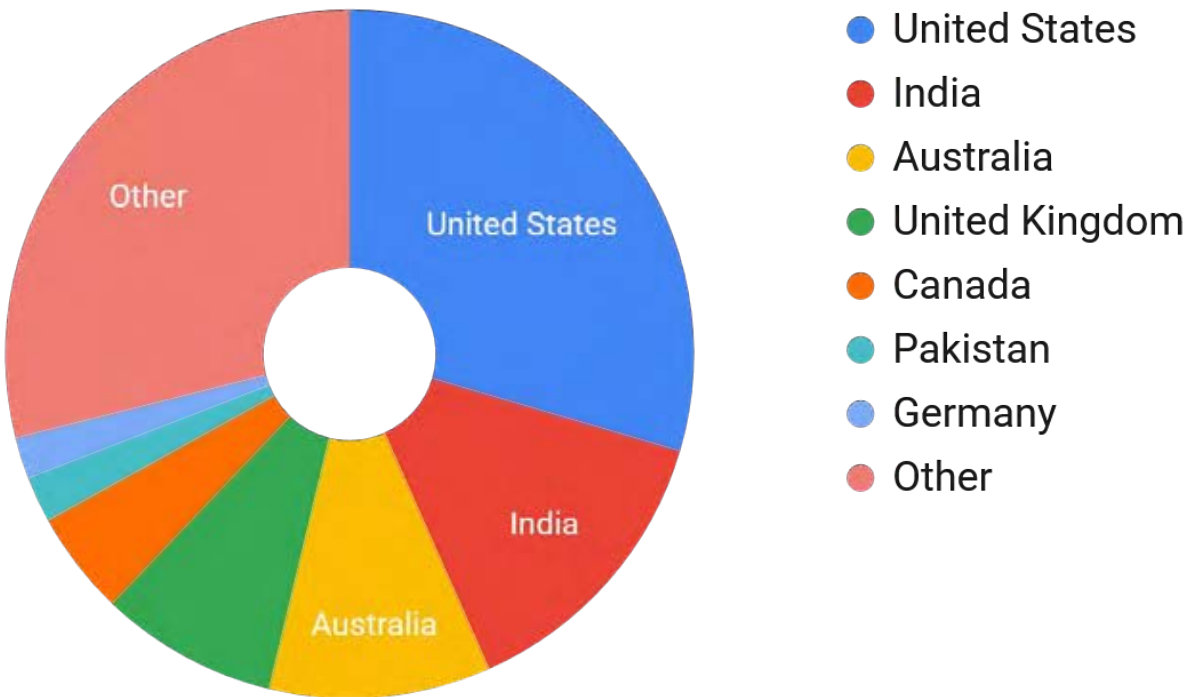

Top completed project categories by count 1H26

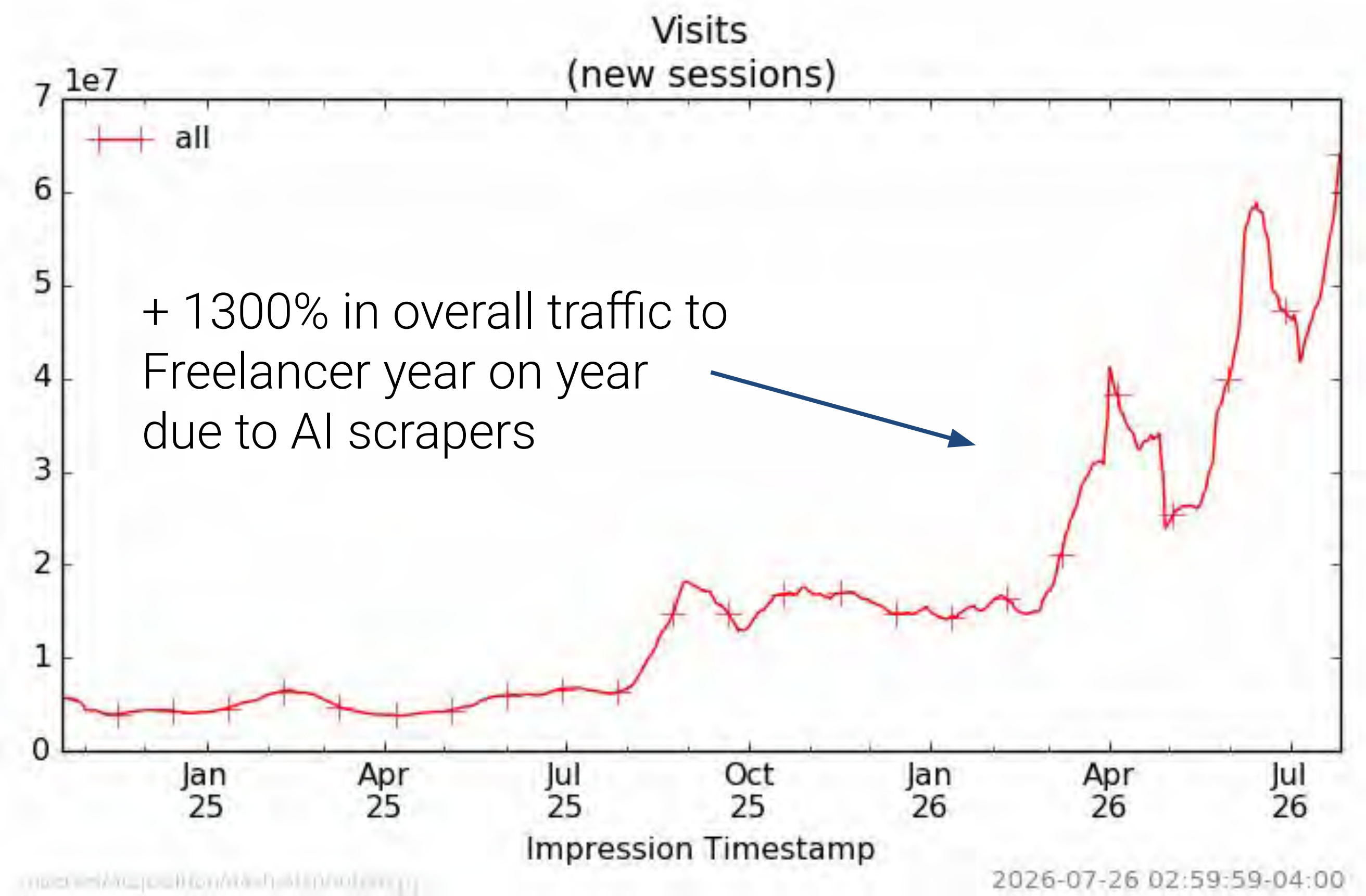


AI jobs in 2Q26 now 7.4% of GMV

Top client countries by completed projects 1H26

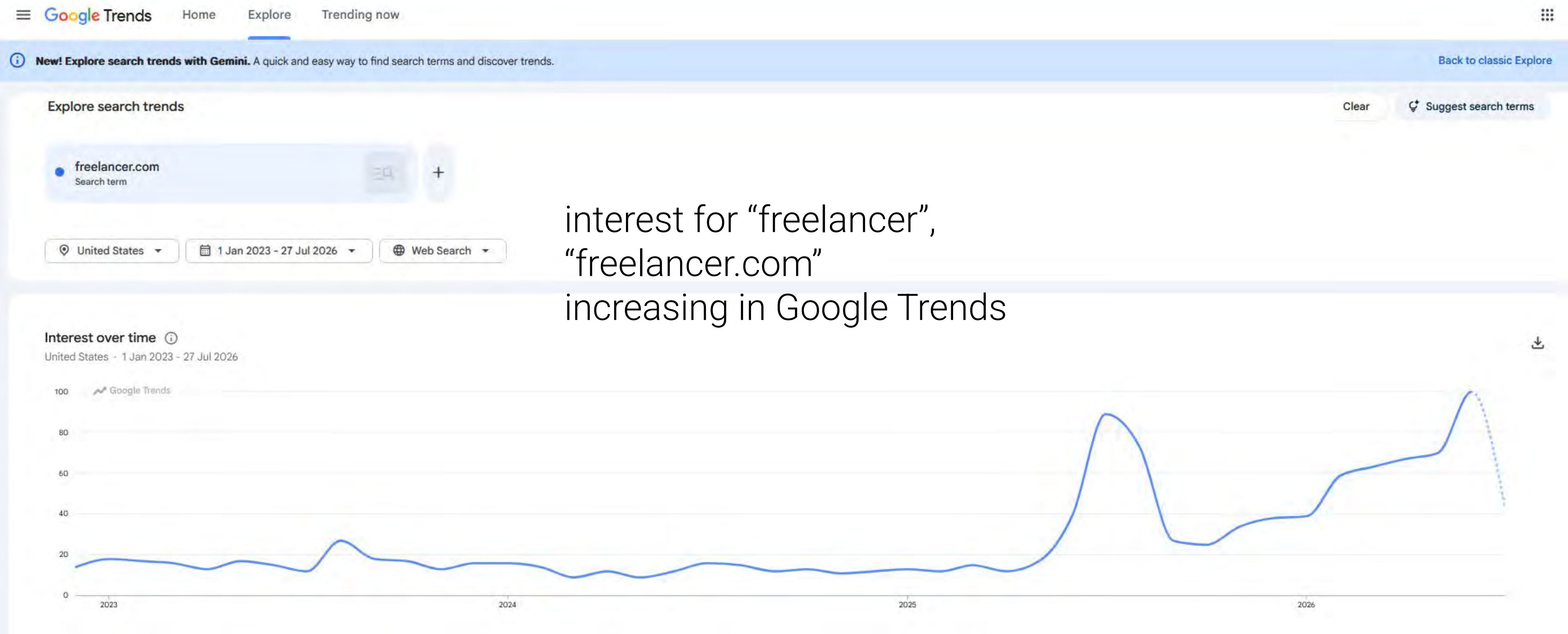

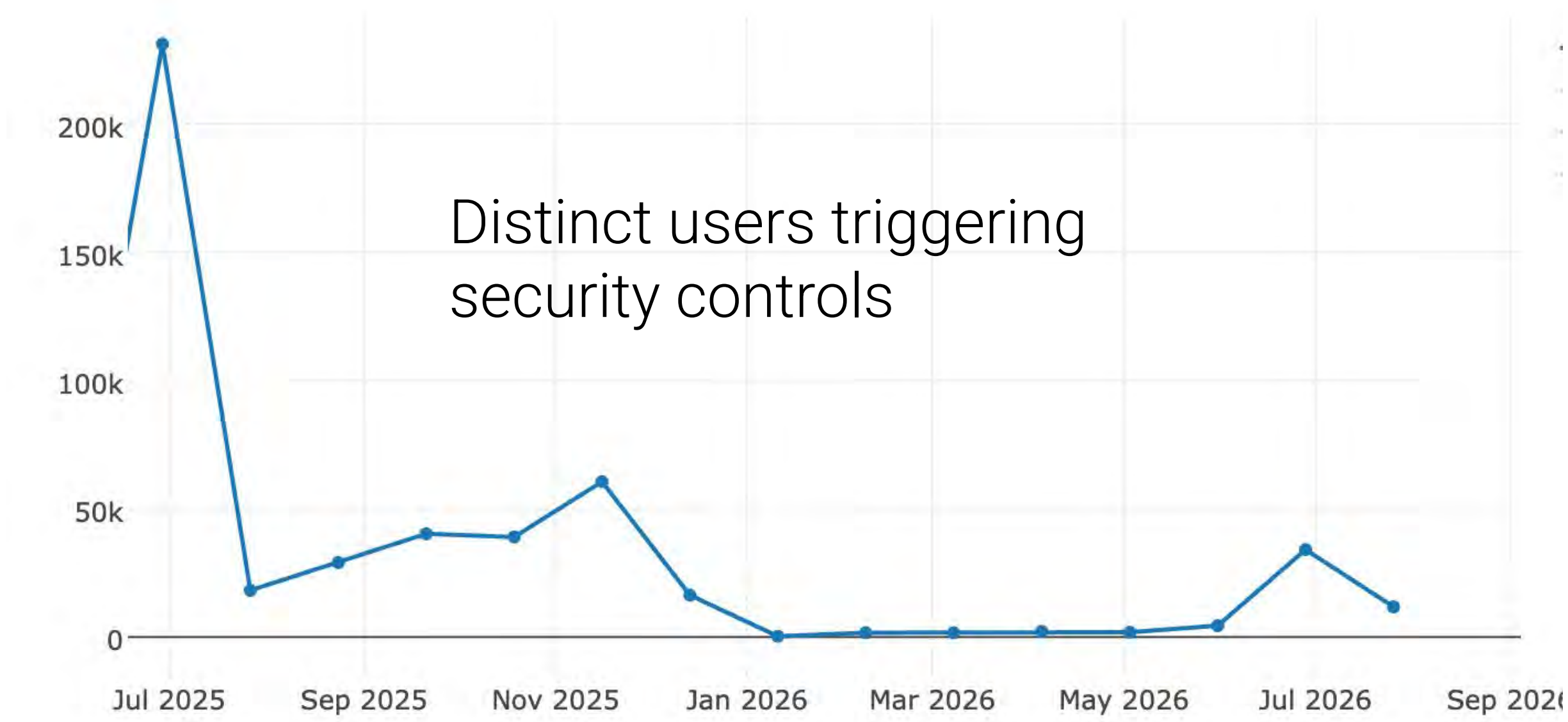

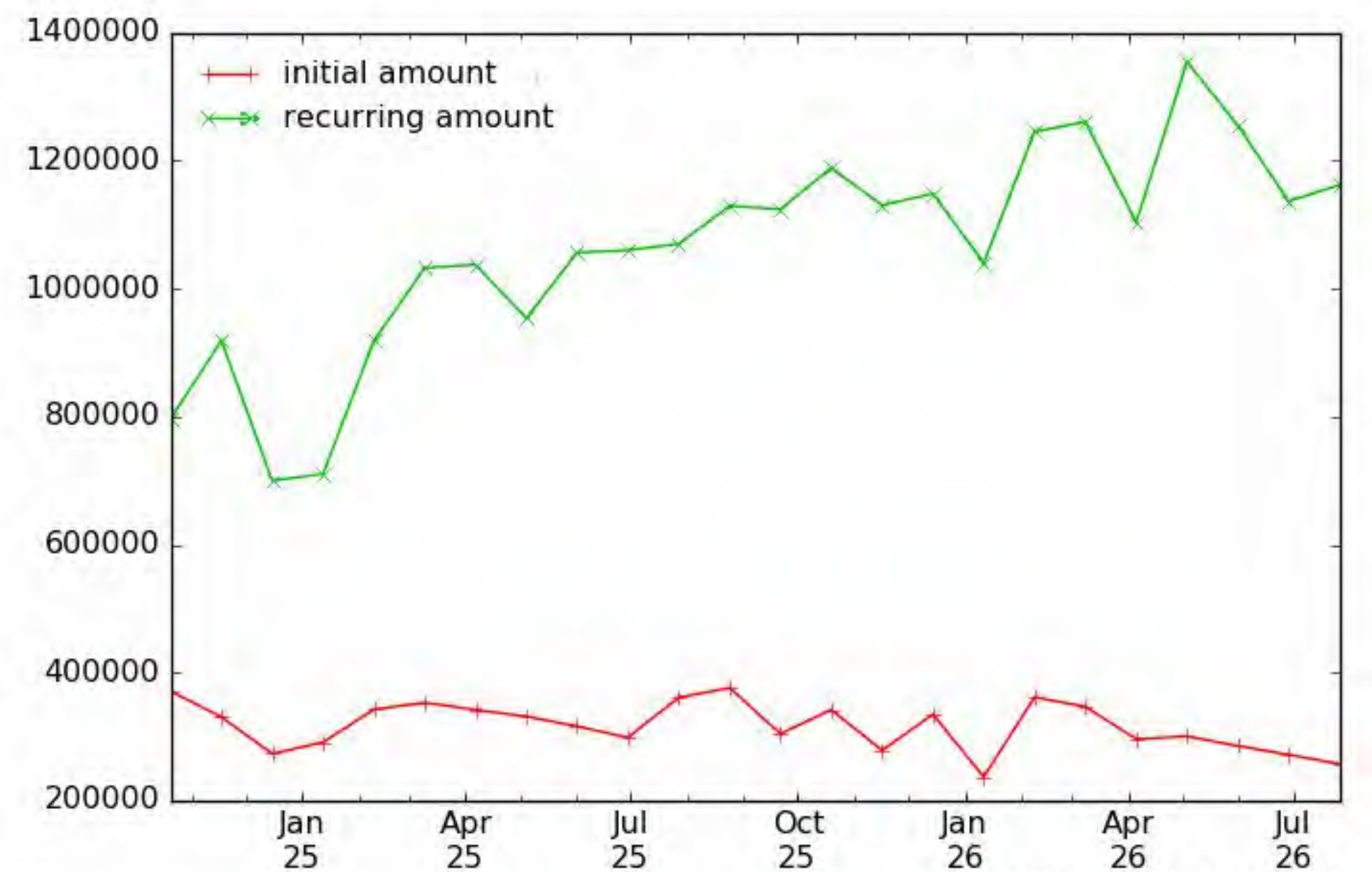

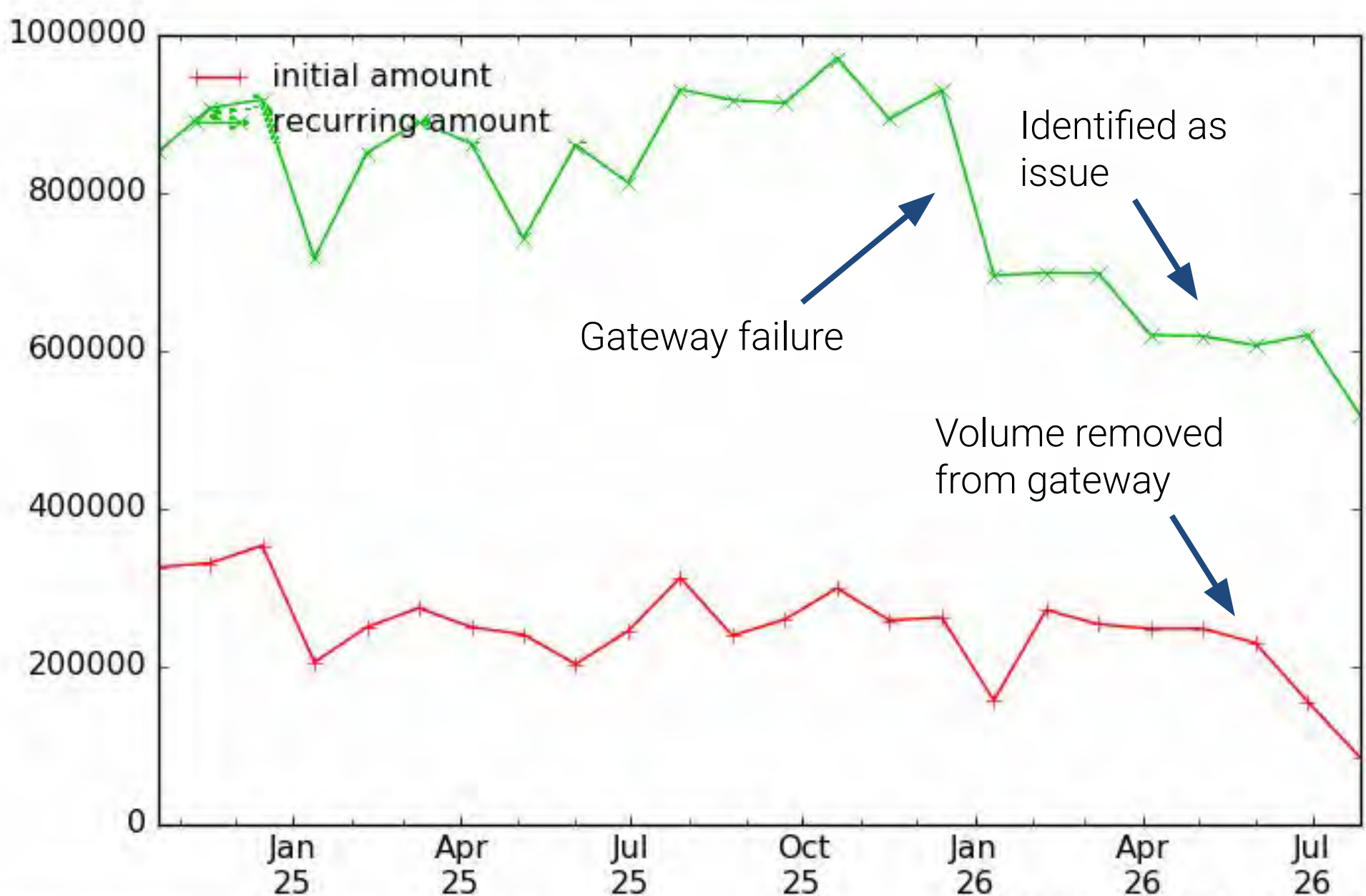

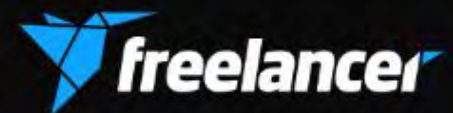

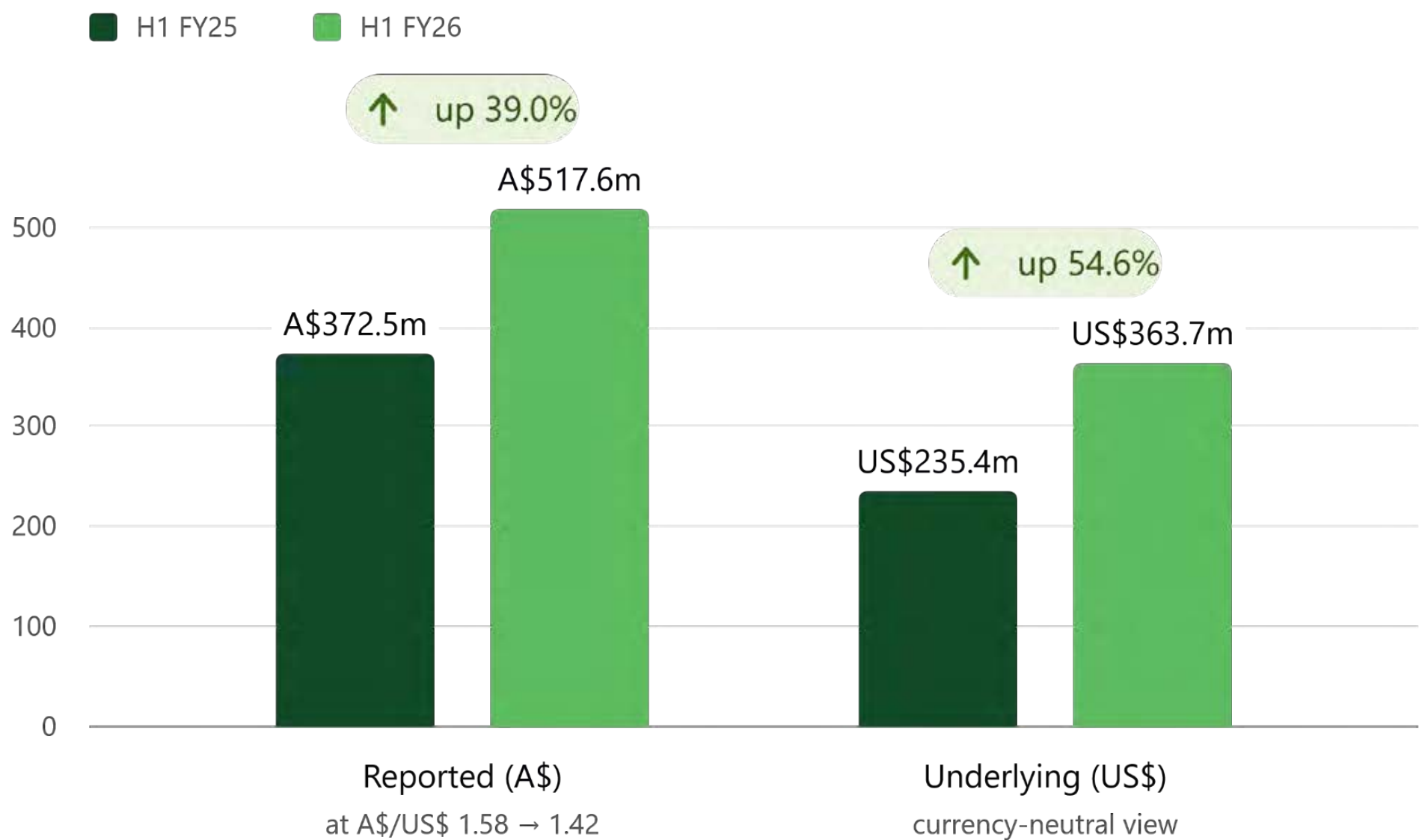

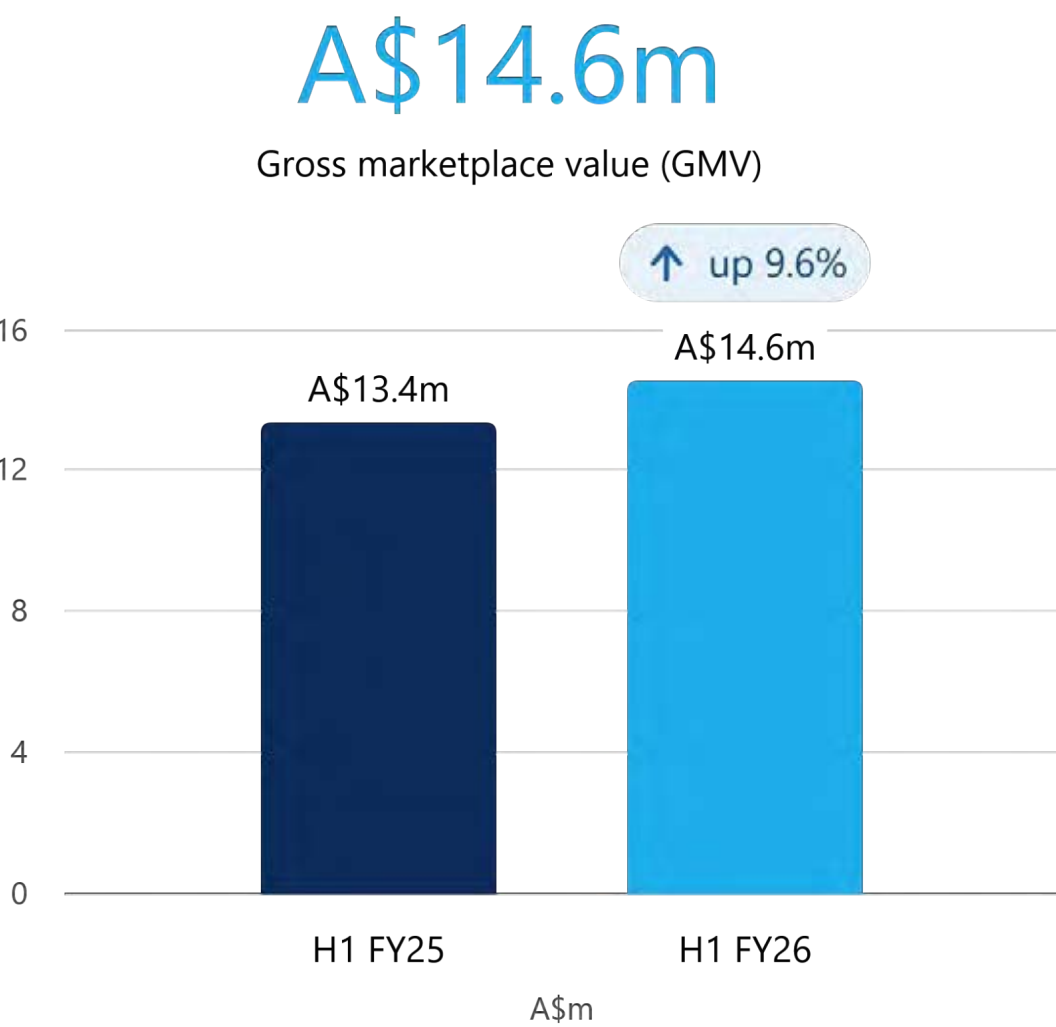

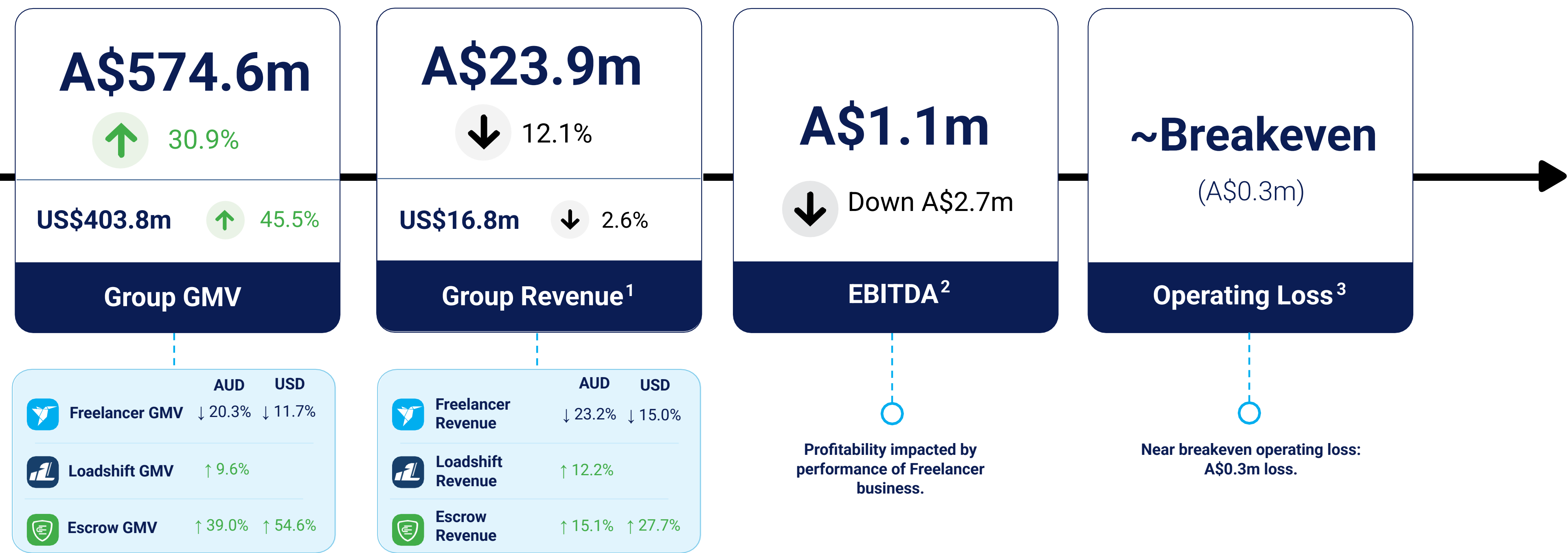

H1 FY26 - Key Metrics

Group GMV increased 30.9% from strong Escrow and Loadshift growth, but overall Gross Profit was down 10.4% due to lower performance in high-margin freelancer business

Freelancer GMV A\$42.4M down 20.3%: lower marketplace activity. On a USD basis, GMV declined 11.7%, with the weaker US dollar amplifying the reported decline.

Performance impacted by:

- Additional login friction following enhanced security controls, including 2FA
- Organic search headwinds from AI scraping, rate limiting and indexation
- Lower payment acceptance following the gateway migration issue

Freelancer revenue A\$14.9M down 23.2% (down 15% on a USD basis)

Loadshift GMV A\$14.6m up 9.6%: continued marketplace activity. PSTN to in-app voice bridge was released, in 2H26 will reduce off-platform activity.

Loadshift revenue A\$1.8M up 12.2%

Gross Profit A\$14.2M down 20.5%

H2 focus: improve product execution, remove conversion friction, rebuild organic traffic and improve customer retention.

Escrow GMV up 39.0%: domain-name transactions remained a core growth driver, complemented by increased activity in wholesale electronics and IPv4 transactions. On a constant currency basis, GMV increased 54.6%, with the weaker US dollar reducing reported growth.

Escrow revenue A\$7.0M up 15.1%: continued the strong growth achieved in recent periods. On a constant currency basis, revenue increased 27.7%.

Take rate reduced to 1.35% from 1.63%: high-value transactions contributed to GMV but carried lower take rates due to the mix and pricing characteristics of larger transactions.

Gross Profit A\$6.5M up 21.8%

Improved operating leverage: revenue growth on a relatively stable cost base drove stronger profitability.

H2 focus: driving further growth in key verticals including wholesale electronics & import/export

Group revenue A\$23.9M down 12.1%: included A\$0.2M of interest income, compared with A\$0.1M in H1 FY25. Strong Escrow.com and Loadshift growth was offset by weaker Freelancer performance.

Gross profit A\$20.9M down 10.4%: the decline was lower than revenue due to relatively fixed cost of sale base of escrow volumes.

Operating loss A\$0.3M: compared with an A\$1.8M operating profit in H1 FY25. Employee and hosting costs were reduced through active cost management, operating efficiencies and supplier negotiations, partly offset by higher AI tooling and Escrow.com compliance costs. The result includes the net cash impact of Sydney leases and sublease income, including rent capitalised under AASB 16.

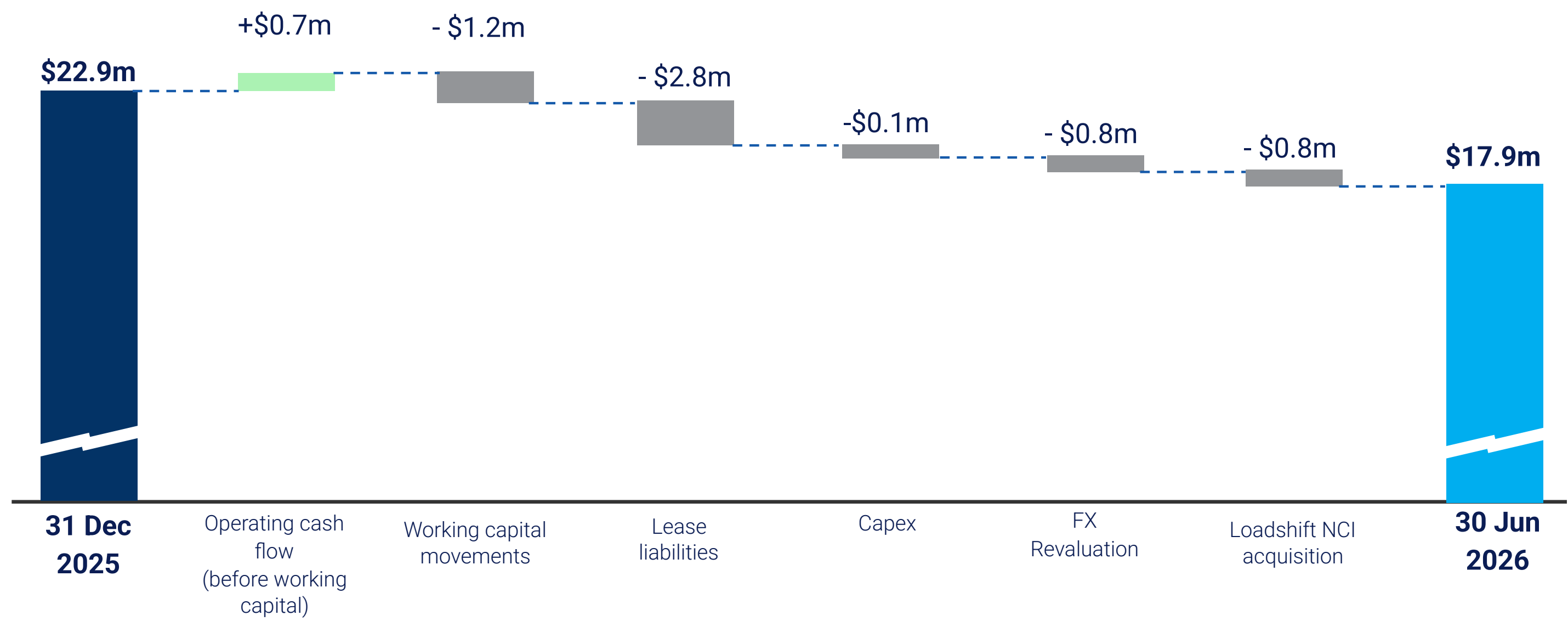
Net loss after tax A\$2.1M primarily driven by a **A\$2.4M non-cash impairment** of non-core digital assets (Warrior Forum, acquired in 2014). The carrying values of the core Freelancer, Escrow.com and Loadshift businesses remained supported.

FX gain A\$0.9M: arose mainly from translating foreign denominated liabilities back to AUD, compared with a similar A\$1.0M gain in H1 FY25.

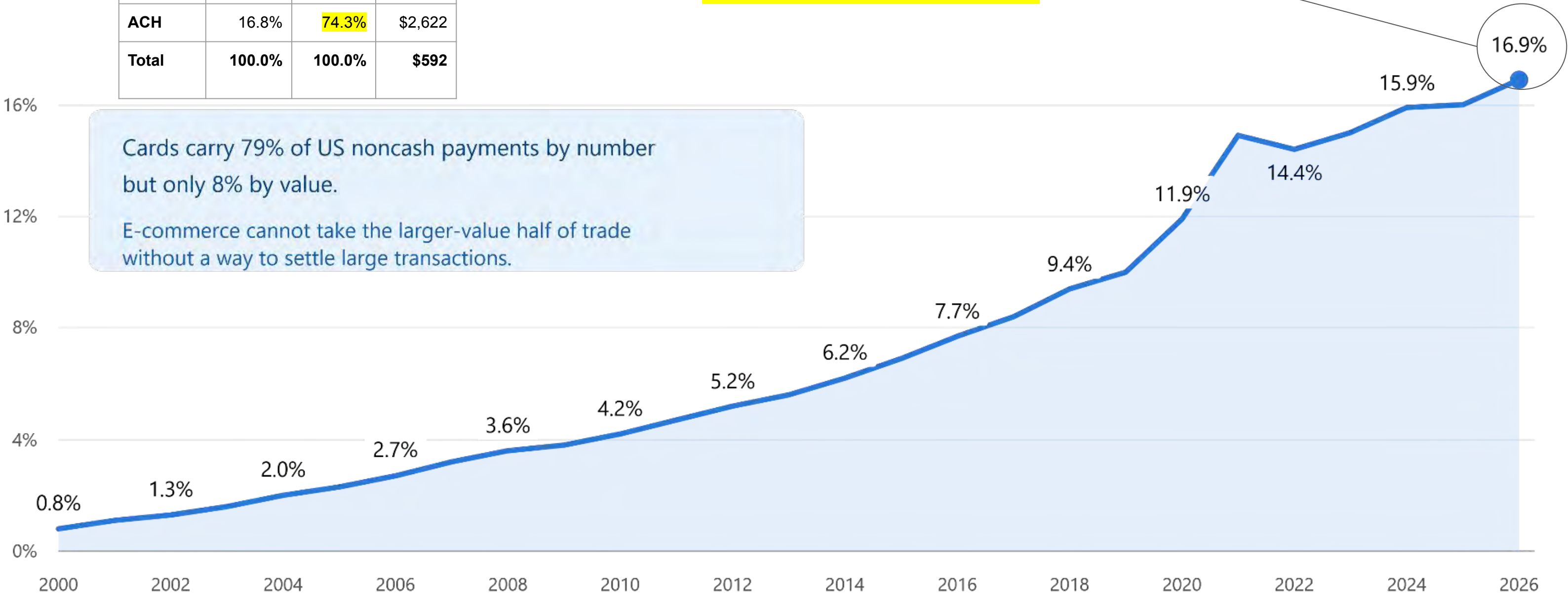

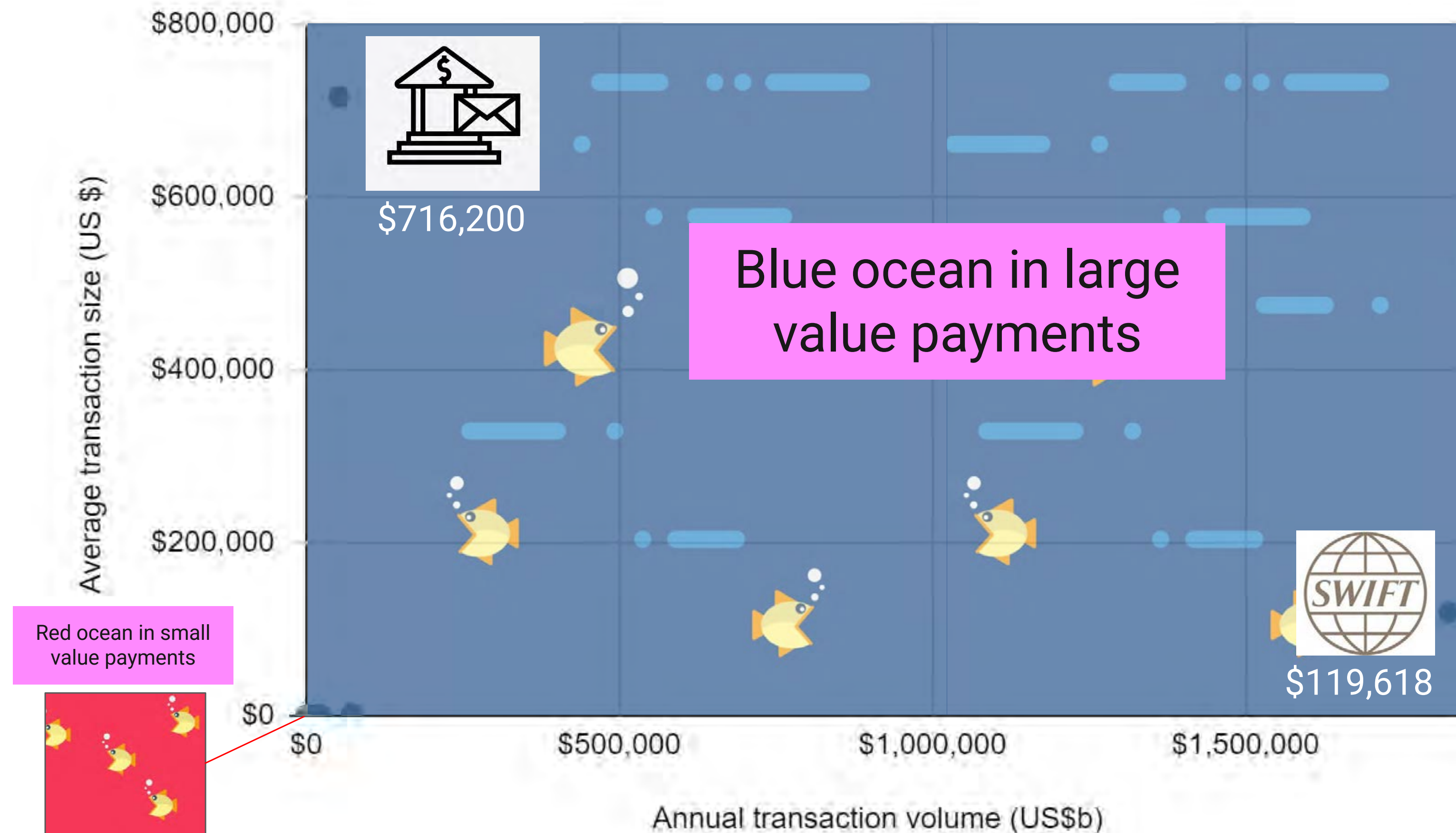
