Answer: No. Focus had an intensive drilling campaign for the first two quarters of 2020 and the next two quarters' activities will be primarily desktop-based. Focus expects the next quarter's net operating cash outflow will be reduced.	
2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	

Answer: Yes, the Company is currently working to raise money in order to support its future operations. The financing options include both debt and/or equity. Focus believes the current negotiations are progressing well but it is too early to determine whether the financing will be successful.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes. Focus expects the next two quarters will be primarily desktop-based activities, so the current cash balance is expected to be able to support its operations.
