

ANNOUNCEMENT TO THE AUSTRALIAN STOCK EXCHANGE: 27 JUNE 2003

ISSUE OF EMPLOYEE SHARE OPTIONS

The board of QED Occtech Limited ("QED Occtech") advises that it will issue a total of 4,900,000 share options under the Employee Share Option Plan that was approved by shareholders at the Meeting held on 3 October 2002.

The options are issued as an incentive and a means to retain senior staff (no Directors are involved), with the options lapsing on 26 June 2007 and being available for exercise over a period of four years (25% per annum) subject to employment conditions being maintained. Each option will be exercisable into one fully paid ordinary share in QED Occtech at an exercise price of 20 cents in accordance with the terms of the QED Occtech Employee Share Option Plan.
