The material terms of the Options are as follows:

- (a) Each option (**Option**) entitles the holder to subscribe for one fully paid ordinary share in the capital of the Company (**Share**) at an exercise price of 2.0 cents (**Exercise Price**).
- (b) The Options are exercisable at any time on or before 5.00pm Western Standard Time on 7 February 2022 (**Expiry Date**). Any Options not exercised by the Expiry Date shall lapse.
