OPTIONS ENTITLEMENT ISSUE – SUPPLEMENTARY PROSPECTUS

On 28 September 2021, Torian Resources Limited (**Company**) announced a non-renounceable pro rata entitlement offer of up to approximately 347,754,860 Options (**New Options**) on the basis of 2 New Options for every 5 existing Shares held as at 5.00pm (WST) on Tuesday, 20 October 2021 (**Old Record Date**) (**Options Entitlement Issue**).

The Offer was made by the Company pursuant to a prospectus in accordance with section 713 of the *Corporations Act 2001 (Cth)*, dated 28 September 2021 (**Prospectus**) proposed to be sent to shareholders on or about Monday, 25 October 2021.

On 18 October 2021, the Company announced that there would be a change to the timetable under the Options Entitlement Issue.

The purpose of this change, and of the Supplementary Prospectus attached, is to set out a revised timetable for the Options Entitlement Issue as a consequence of changing the Old Record Date to 5.00pm (WST) on Friday, 29 October 2021 (**Updated Record Date**).

The Board resolved to extend the Record Date to the Updated Record Date after becoming aware that a number of shareholder queries regarding the exercising of Options (ASX: TNRO) had not been responded to due to the change in Company Secretary (as announced on 12 October 2021).

The Company therefore attaches a Supplementary Prospectus, which supplements the Prospectus and is to be read together with the Prospectus.

Other than the changes set out in this Supplementary Prospectus, all other details in relation to the Prospectus remain unchanged.
