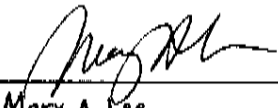
DIRECTIONS

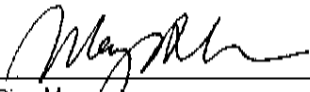

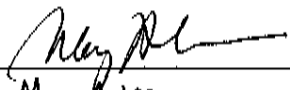
