	Answer: Yes, subsequent to the end of the quarter, the Company executed a US\$1 million working capital facility with its largest shareholder, Tembo Capital, and announced a two-tranche placement to institutional, sophisticated and professional investors to raise up to AU\$10 million. Tranche 1 of the placement completed on 14 October 2024 raising AU\$8.5 million (before costs). Tranche 2 of the placement is scheduled to complete on 2 December 2024, subject to receipt of approvals. If shareholder approval and FIRB approval are obtained to permit Tembo Capital's participation in tranche 2 of the placement, then the total subscription amount of AU\$1,450,000 payable by Tembo Capital to the Company will be set-off against the principal amount owing by the Company to Tembo Capital under the working capital facility, thereby effectively converting the loan to equity via Tembo Capital's participation in the placement.
