**NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT**

As announced on 3 February 2026, Grand Gulf Energy Ltd (ASX:GGE) (**Grand Gulf** or the **Company**) received firm commitments from sophisticated and professional investors to undertake a placement to raise \$500,000 (before costs) through the issue of 250,000,000 fully paid ordinary shares in the capital of the Company (**Shares**) (**Placement Shares**) at an issue price of \$0.002 per Placement Share. The Company has today completed the issue of the 20,000,000 Lead Manager Options.
