Issue of Securities

Gold Mountain Limited (“**GMN**” or “**Company**”) advises that 7,984,800 new fully paid ordinary shares (“**Shares**”) in the Company along with 3,992,400 free attaching options (“**Options**”) shall be issued for the placement of shares (“**Placement Shares**”) at a price of \$0.10 per share.

The sum of \$798,480 raised represents part of the subscription moneys received and increasing the previously committed funding of \$3.7 million placement from a group of sophisticated investors as announced to the market on 24 July 2017.

The Placement Shares has with a free option entitlement of one (1) for every two (2) Shares issued. A total of 37,229,600 Shares and 18,614,800 Options have been or being issued. The share options are exercisable at \$0.15 and expires on 30/6/2019.

The funds raised are to be used for the purposes of meeting general working capital requirements and supporting on-going exploration activities with the aim to establish a maiden mineral resource in the Company’s flagship project in Papua New Guinea.

Pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) (“**the Act**”), the Company gives notification that:

- a) The total of 7,708,943 securities comprising of 5,139,296 Shares and 2,569,647 Options are issued without disclosure to investors under Part 6D.2 of the Act;
- b) As at the date of this notice, GMN has complied with the provisions of Chapter 2M as they apply to GMN, and section 674 of the Act; and
- c) As at the date of this notice, there is no information that is ‘excluded information’ within the meaning of the sections 708A(7) and 708A(8) of the Act which is required to be disclosed by GMN under section 708A(6)(e) of the Act.
