GrainCorp announces a Conversion Number in accordance with the terms of the Reset Preference Share Prospectus dated 7 July 2003 of **13.3146** ordinary shares to be issued for every Reset Preference Share held. Please note, where the total number of ordinary shares to be allotted on conversion includes a fraction, that number will be rounded down to the next whole number.

The Conversion Number has been calculated as follows:

Conversion Number = Issue Price / (VWAP x (1-CD))

[where VWAP is the volume weighted average price of ordinary shares traded in the proceeding 20 business days, and CD means the conversion discount of 2.5%]
