GREAT WESTERN EXPLORATION LIMITED (ASX:GTE) - ACQUISITION OF MINING TENEMENTS

Great Western Exploration Limited (**GTE**) is pleased to announce that it has today completed the acquisition of Jindalee Resources Limited's (**ASX:JRL**) 20% interest in the Forrestania area as announced on the 18th March 2008.

The company now retains 100% ownership of Exploration Licences 74/181, 74/320, 74/305, 74/313 and 77/1329, Exploration Licence Applications 74/368, 77/1545-1547, 74/251 and 63/1201, and Prospecting Licence Application 74/251.

As consideration for the acquisition the company has issued 2,000,000 fully paid ordinary shares to Jindalee. An appendix 3B and notice pursuant to Section 708A(5)(e) of the Corporations Act in respect of these shares is attached to this announcement. The company has also agreed to issue to Jindalee 2,000,000 options exercisable at 40 cents on or before 20 June 2012 as consideration for the acquisition, subject to obtaining shareholder approval for the issue of the options.

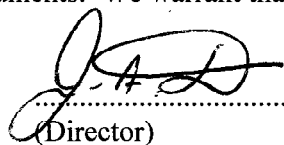

Notice under Section 708A
