NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001

Waratah Resources Limited (**ASX:WGO**)(**Company**) is pleased to announce the allotment and issue on 8 January 2013 of 5,000,000 fully paid ordinary shares at an issue price of \$0.06 per share to a sophisticated investor (**Securities**) . The funds are to be used to further fund the Company's projects and general working capital.

The issue of these Securities was approved by the shareholders at the Annual General Meeting held on 29 November 2012. For further details regarding the background to the issue of the Securities, please refer to Resolution 9 of the Notice of Meeting released to the ASX on 25 October 2012.

Secondary Trading Exemption

The *Corporations Act 2001*(**Act**) restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, sale of the Securities noted above will fall within the exemption in section 708A(5) of the Act.

The Company hereby notifies ASX under paragraph 708A(5)(e) of the Act that:

- (b) as at 8 January 2013 the Company has complied with the provisions of Chapter 2M of the Act as they apply to the Company, and section 674 of the Act;

 - (i) that has been excluded from a continuous disclosure notice in accordance with the ASX Listing Rules; and
 - (ii) that investors and their professional advisers would reasonably require for the purpose of making an informed assessment of:

- (A) the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
- (B) the rights and liabilities attaching to the Securities.
