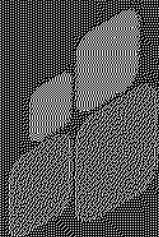
Re: Resources Rising Stars - Presentation

Map

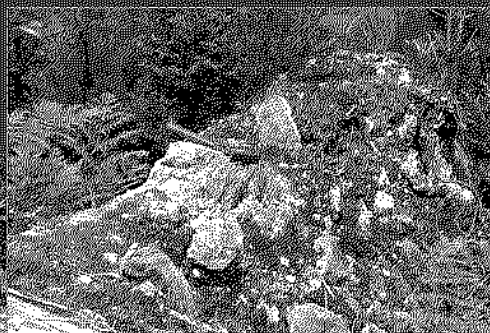


1. A realistic early cash flow opportunity – with growth potential.

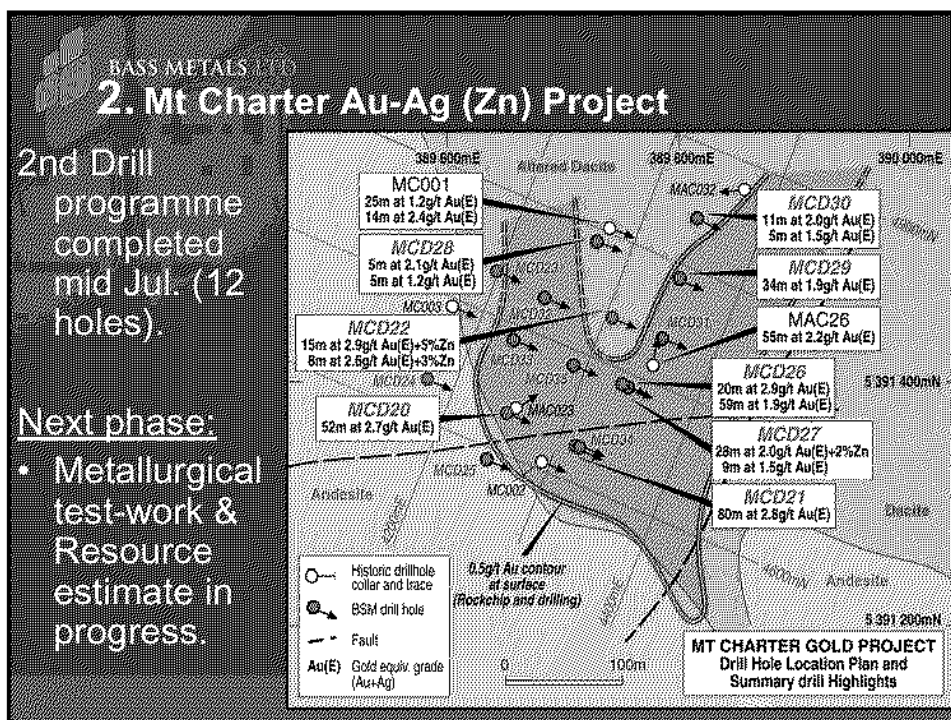
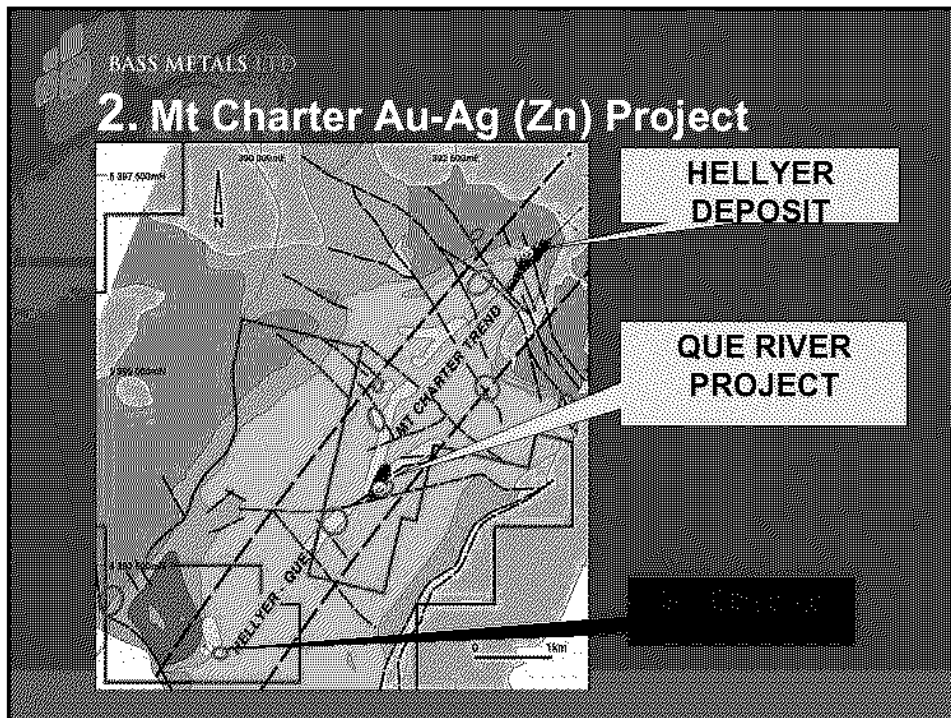
- Potentially high margin ore
- Mining alliance with Mancala to run all operations
- Scoping study – up to \$9.0M cash surplus.
- Enhancements underway – significant improvements expected.
- Discussions on ore sales/toll processing for Que River ore with Zinifex and Intec (Hellyer) started.
- Production planned to commence late this year.

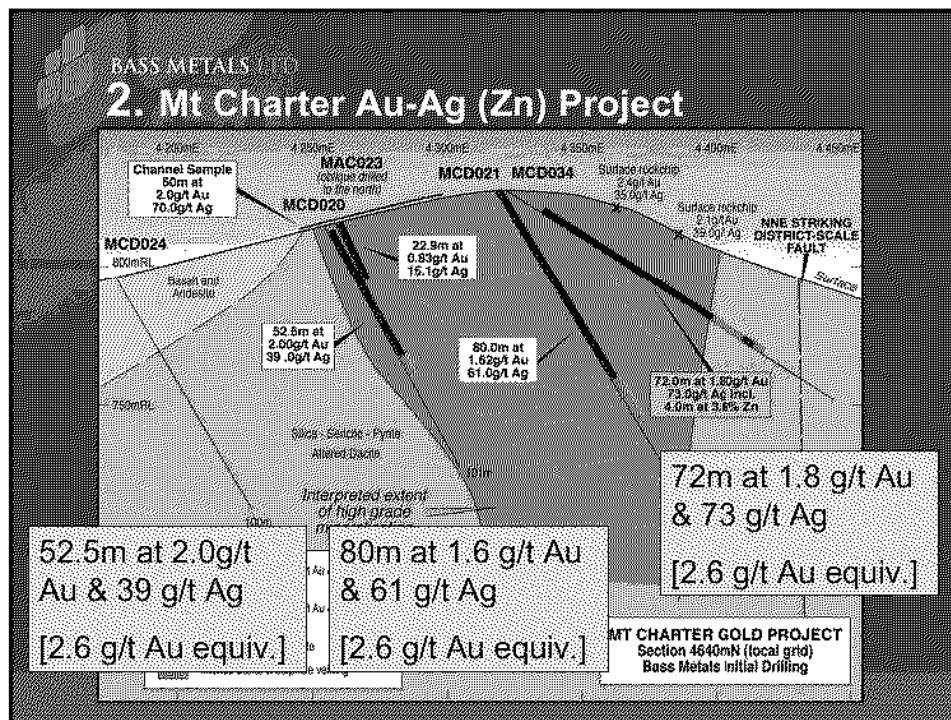
2. Mt Charter Au-Ag (Zn) Project

Large, shallow gold-silver system.

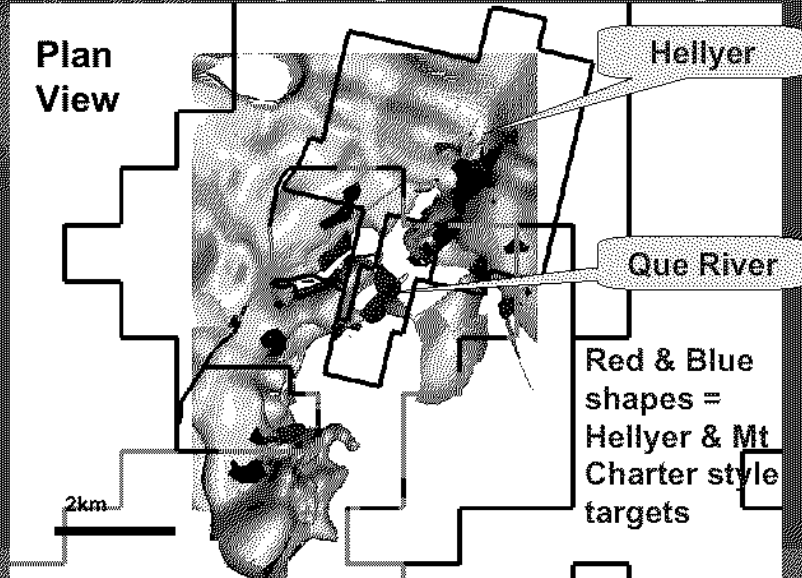
3. Hellyer Exploration Alliance (HEA)

- 50:50 alliance with Zinifex Limited (ASX:ZFX), managed by BSM.
- ZFX-a major global zinc producer – Mkt Cap = A\$5.8bn. Recently reported NPAT of A\$1.1bn.
- Exploration technology alliance with Geoinformatics Exploration (TSX.V:GXL) – proven ore finders.
- Objective is to discover a new Hellyer deposit on the Hellyer Project...an Elephant!
- Planning to spend c. \$1.7M in next 12 months – mainly on drilling.
- 13 highly ranked target areas.
- Drilling has started.

Ongoing drilling

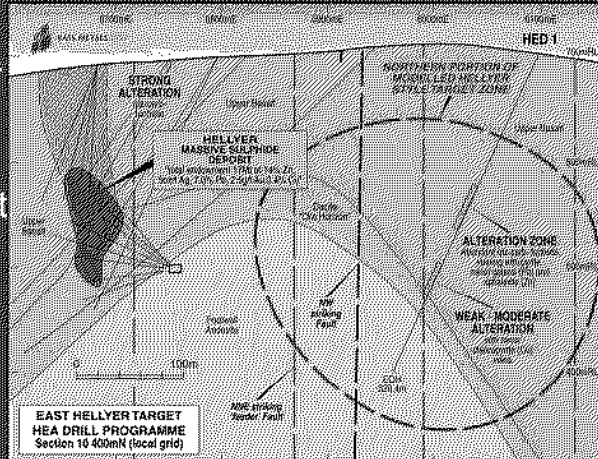


- Drill hole HED1 on the former Hellyer Plant ROM pad

- Start of a 7,000m, 19 hole programme.

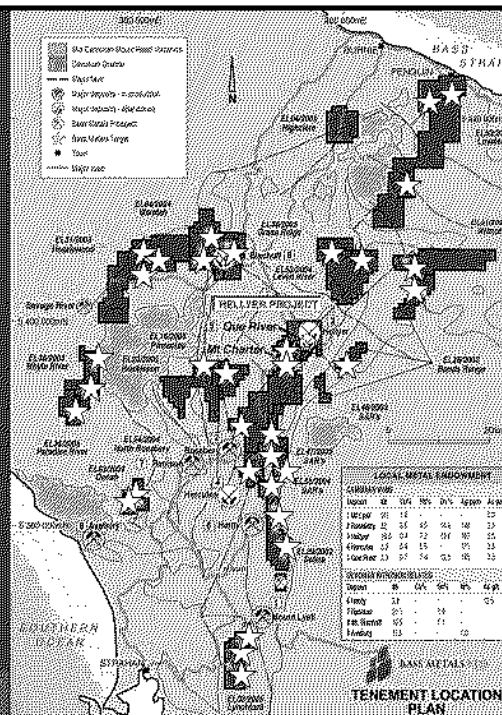


- 4 holes planned
- 1st hole – to validate model hit Hellyer style alteration with minor visible Pb-Zn-Cu mineralisation.

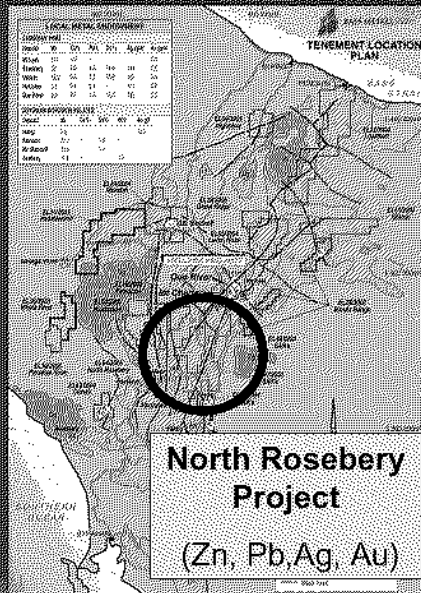


Drilling ongoing – 7000m planned

- Elephant Hunting
- Dominant ground position in prospective areas
- 8 months "lab" work to generate 65 targets prospective for new large scale deposits.
- Results starting to emerge eg North Rosebery

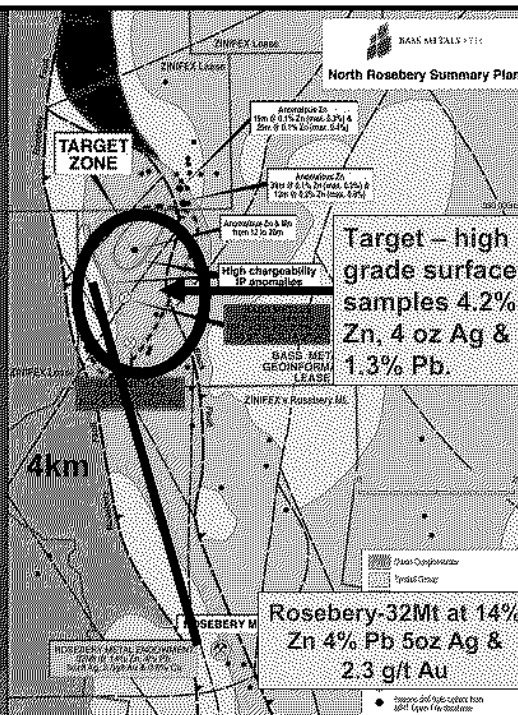

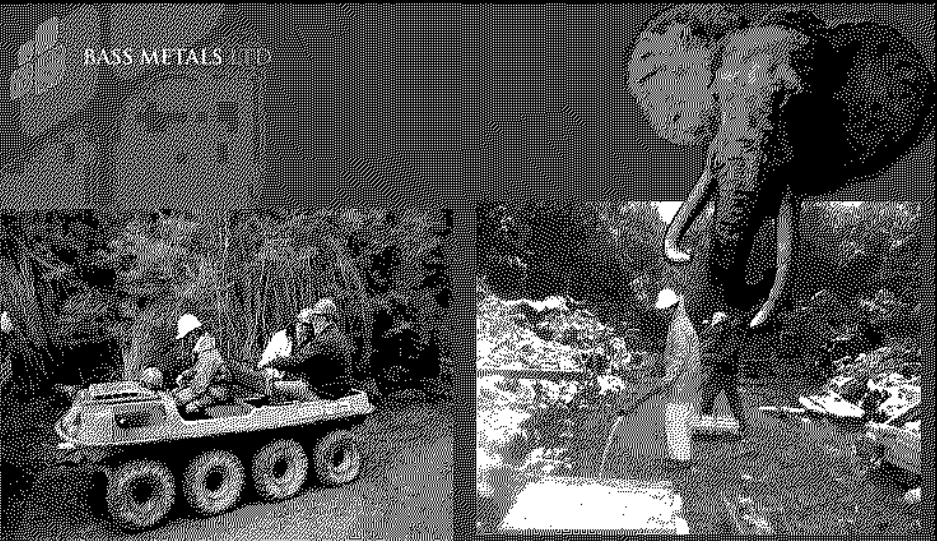
