1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer:

The current quarters expenditure is not considered representative of the expected level of net operating cash outflows in the coming quarters due to most legacy amounts owing being settled during the September quarter. It is expected to be significantly lower in the coming quarters. There has also been a further reduction in the size of work force.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer:

On 2 June 2020, the Company announced an equity raising consisting of a placement, conditional placement and share purchase plan for a total of A\$3 million. The conditional placement raising \$1.35 million was approved by shareholders at a meeting held in September 2020 and was partly settled during the period with further amounts settled after the end of the quarter.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer:

Yes, on the basis of the reduced cash outflows and expected cash inflows.

The Company has settled on a strategy to maximise progress with a significantly reduced cash outflow. The focus at this time is on continued exploration and expanding the mineral resource in conjunction with progressing the definitive feasibility study for development of large scale mining and processing operation. This is achievable with materially lower cash outflows than prior quarters.
