Achievements



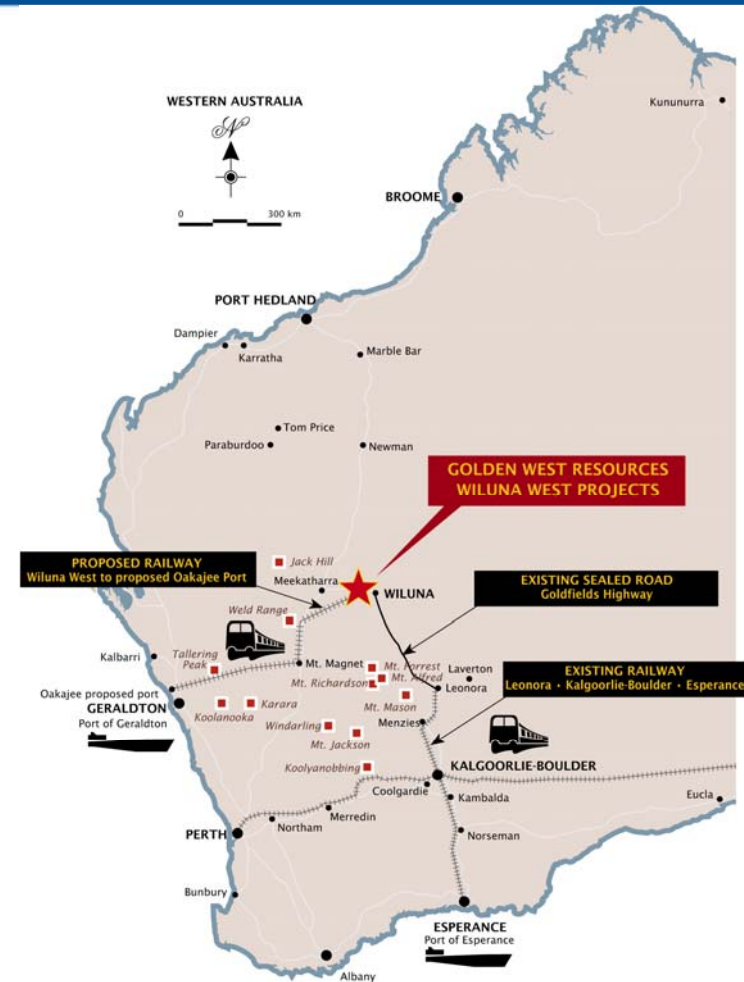
- 23rd November 2010; GWR secures 3Mt per annum port allocation at Esperance
- 10th December 2010; GWR executes Agreement to pursue gold acquisition in West African country of Senegal, from Silvrex; GWR still holds a 16% interest in Silvrex
- 23rd December 2010 GWR announces a share placement and share purchase plan @ \$0.80 per share which raised a total of \$21.95M
- 24th May 2011; Wiluna West DSO hematite Resource update with 50% increase in Measured and Indicated Resources, based upon an extensive infill RC drilling program.
- 8th July 2011; Wiluna West DSO hematite Resource update, with 80.9Mt in Measured and Indicated categories and global Resource of 130Mt @ 60% Fe
- 31st August 2011; Maiden Reserve statement for Wiluna West of 69.2Mt @ 60.3% Fe (Proven 2.9Mt @ 59.7% Fe and Probable 66.4Mt @ 60.3% Fe), confirming the high quality and low contaminants for the DSO hematite deposits

- Tenement holding 267km²
- Granted mining leases over main project area
- DSO hematite Mineral Resource Estimate of 130Mt @ 60% Fe
- DSO hematite Mineral Reserve Estimate of 69.2Mt @ 60.3% Fe
- Gold Mineral Resource Estimate of 3.5Mt @ 2.3g/t for 258,000 oz

DSO Hematite Project Status



- **Mining Approvals**

- JWD Stage 1 Mine (up to 2Mt per year via Esperance Port)
 - Mining Proposal currently at DMP awaiting approval pending SEC18 application @ DIA
- Stage 2 Mine (5 to 7Mt per year via proposed Oakajee Port)
 - Flora & Fauna surveys largely completed, final fauna survey November 2011
 - PER presently being compiled for submission to EPA in January
 - Approvals expected within 2 years

- **Native Title**

- Mining Agreement executed in July 2010

- **Aboriginal Heritage**

- SEC 18 application for JWD Stage 1, pending at DIA
- Heritage Management Plan for entire project due for completion in December



Infrastructure



- Government has appointed Deloitte's to carry out a review on a number of WA ports, including Esperance.
- GWR has taken a lead role in the establishment of an “alliance” of “near term” Yilgarn based miners.
- Seeking early access through EPSL to take up the Port's latent capacity of approximately 7mtpa.
- Uncertainty surrounds Oakajee, earliest completion date estimated at 2016.
- Oakajee continues to be the “pathway of choice” – commercially desirable.



Iron Project Generation



- GWR has actively been pursuing other DSO hematite projects within the Midwest region
- Earraheedy (recently acquired 1382km²)
 - Located 200km north east of Wiluna
 - Within Earraheedy Basin
 - Highly prospective for hematite and manganese deposits
- Booylgoo Springs (12km²)
 - Located 100km south of Wiluna West project
 - Prospective for hematite and magnetite deposits
- Other
 - Reviewing a number of other opportunities



Wiluna West Gold Project



- Aiming to commence gold mining operations in 2012 via toll milling arrangement with nearby milling facility.
- Wiluna West has a number of gold deposits with a combined Resource of 3.5Mt @ 2.3g/t Au for 258,000 oz
- Preliminary infill & confirmatory RC drilling at the Golden Monarch, Iron King & Bottom Camp deposits completed in November 2011
