RE : Late lodgment of Appendix 3Y

The attached Appendix 3Y form relates to 20,000 ordinary shares in Havilah Resources purchased on market by a director, which is being lodged more than five business days after the change occurred in contravention of Listing Rule 3.19A.2.

In this regard the Company advises as follows :

1. The reason for the late lodgment was inadvertent oversight, which only came to light upon an annual audit of Director's interests.
2. The Company has in place a strict policy that Directors must notify the Company Secretary immediately upon the occurrence of any Director related transaction.
3. During the Company's history there have been many Director related transactions and all except this one instance have been reported on time, indicating that the policy is effective and consequently no changes are planned at this stage. Given this breach, the Company Secretary will take the opportunity to remind Director's of their obligations in this regard
