

Results of Annual General Meeting of Shareholders 19 November 2015

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001, the following information is provided in respect of each resolution considered and voted upon at the Annual General Meeting of Shareholders of Carpentaria Exploration held today. Resolutions 1 and 4 were not carried. Resolutions 2 and 3 were carried.
