DIRECTOR'S INTEREST NOTICES

On 1 August 2008, Jetset Travelworld Limited lodged Appendix 3Z (Final Director's Interest Notice) in relation to former Director Barry James Samuels. Mr. Samuels, who ceased to be a Director on 25 July 2008, has an indirect interest in the shares reported in that document which are held in the name of Enta Pty Limited.

In the 1 August 2008 Announcement, it was noted that a discrepancy between the number of shares reported in that Appendix 3Z and the number of shares reported in the last notice, Appendix 3Y (Change in Directors Interest Notice) lodged on 17 January 2002, had become evident.

Investigation has revealed:

1. the number shares reported in the Appendix 3Y lodged on 17 January 2002 was 385,713. Based on the share register at that time, it would appear that this number should have been 386,719 shares;
2. during February and March 2003, the Company was subject to a proportional takeover by Sintack Pty Limited. In that process, parcels of 42,857 shares (on 27 February 2003) and 128,574 and 60,600 shares (both on 12 March 2003) were disposed of to Sintack Pty Limited by Enta Pty Limited. The Company omitted to report these disposals to the Market at that time and two Appendix 3Ys reporting these disposals are attached to this Announcement; and

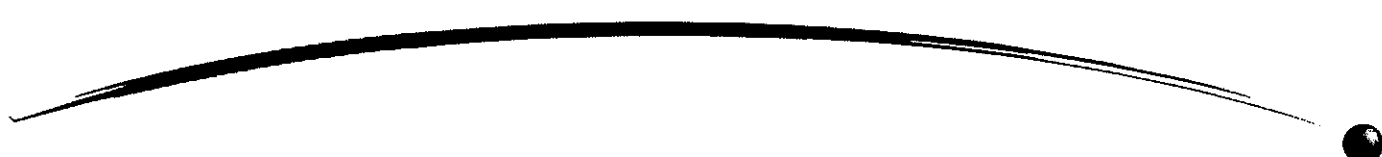
