The securities are issued, pursuant to a Long Term Incentive Plan (LTIP), to a targeted group of key executives and senior leaders who report to the CEO or senior leaders.

The scheme commenced on 1 July 2016.

The 350,000 securities were granted to new executives, effective 1 July 2017. The vesting date for these shares is 1 July 2020. Vesting is dependent on achievement of threshold performance criteria directly linked to Total Shareholder Return (TSR) over a three year period. 50% vesting will occur at a \$5.50 share price / TSR of 13% p.a., and there is prorated vesting up to the target of a \$6.50 share price / TSR of 19% p.a. Individuals will also need to meet individual KPIs as determined by the Board and CEO over the three year period.

A loan is provided to each participant equal to the VWAP share value at the grant date and the number of shares issued. The loan is repaid to the company on the sale of the vested shares.

A holding lock will be placed on the shares until vesting date and the performance criteria have been assessed.

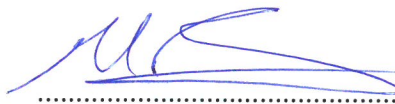
