3D-IP modeling for Overlander Central and Andy's Hill defines large chargeable and low resistivity targets.

Hammer Metals Limited (**ASX: HMX**) ("Hammer" or "the Company") wishes to update shareholders on the Company's activities on its Mount Isa projects.

- A program of geological mapping and 3D-IP (Induced Polarisation) geophysical surveying and analysis commenced at Overlander and Andy's Hill in mid-February and was completed in mid-April. The survey was the first of its type in the Project area.
- Inversion modelling of the IP lines completed to date over the Overlander North, Overlander Central and Andy's Hill Iron Oxide Copper-Gold (IOCG) targets has enhanced the understanding and prospectivity of gravity and magnetic targets generated late last year (Refer to ASX releases dated 26/11/2014 and 18/3/2015).
- At Andy's Hill the IP chargeability iso-surfaces outline an anomaly, which is in excess of 500 metres in length (at the 20mv/v level). The initial testing of this anomaly will commence as part of the current drilling program. The IP chargeability anomalies tend to be located on the margins of the more intense gravity and magnetic zones.
- At Overlander Central, IP and resistivity iso-surfaces indicates that the Rhyolitic Crackle Breccia has a chargeability and low resistivity signature that will also be targeted by drilling.
- Geological mapping completed at Overlander and Andy's Hill identified extensive magnetite alteration and secondary copper mineralisation at surface above the overlapping IP, gravity and magnetic targets;

The current drilling program is designed to provide an initial test of targets at Overlander North, Overlander Central Andy's Hill as well as the existing IP and geochemical anomalies at Hammer Time located 2km to the west of Kalman.

The following figures show several of the IP anomalies present within the surveyed area and their relationship to the magnetic and gravity models and copper-in-soil geochemistry.

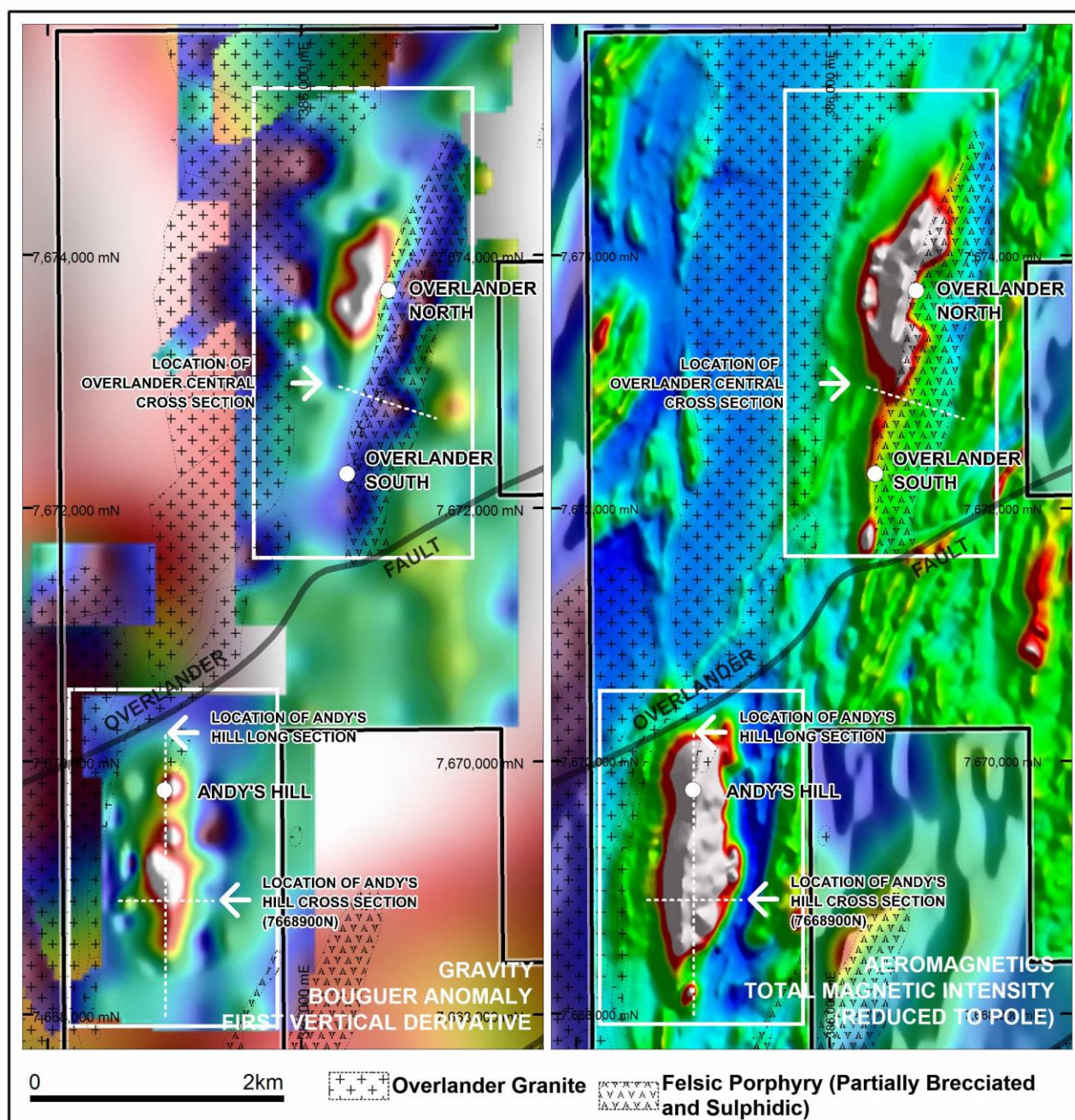

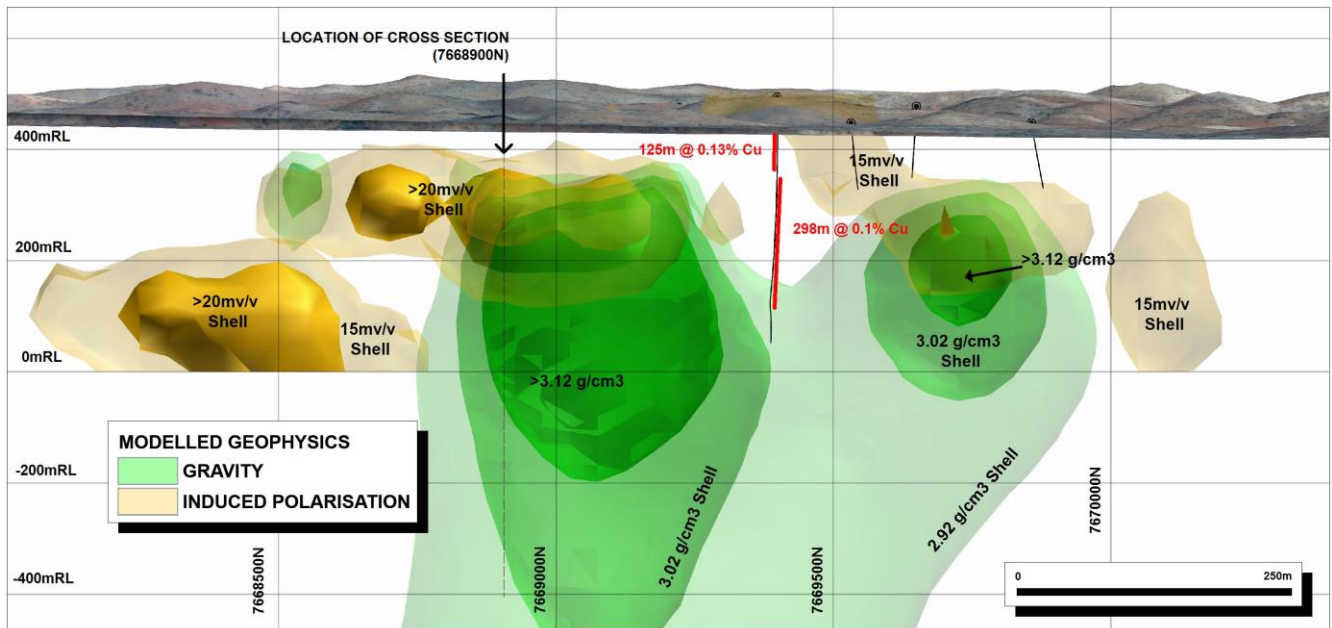

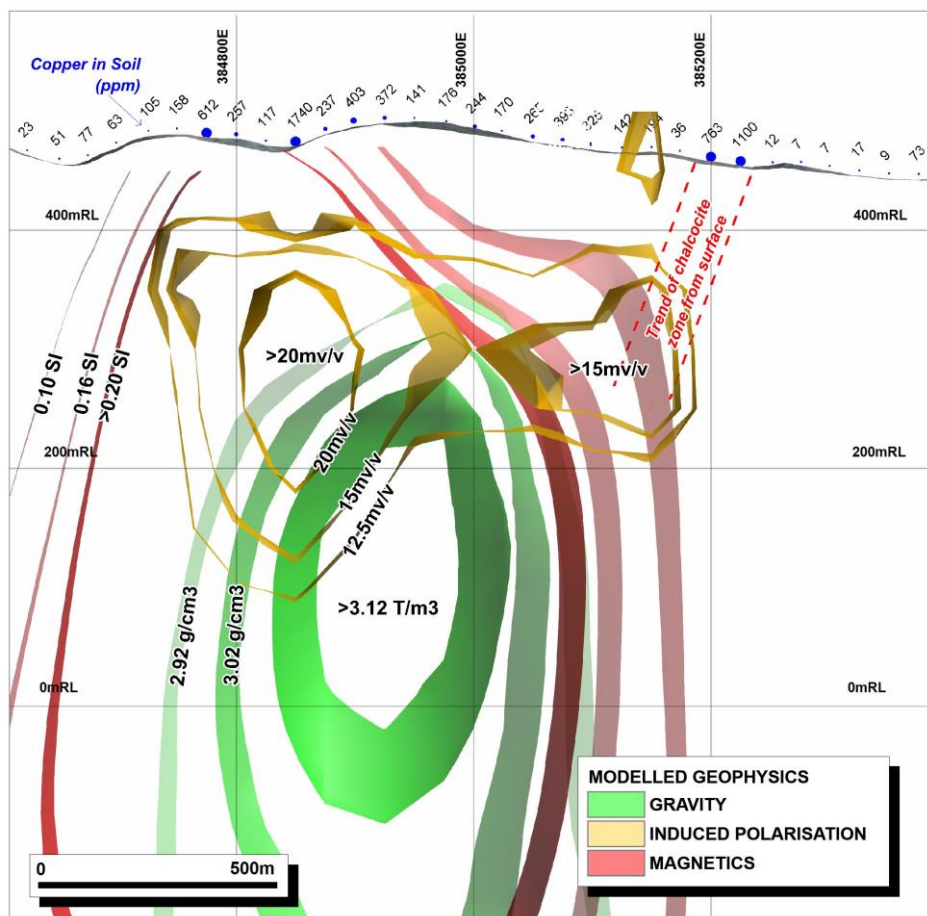

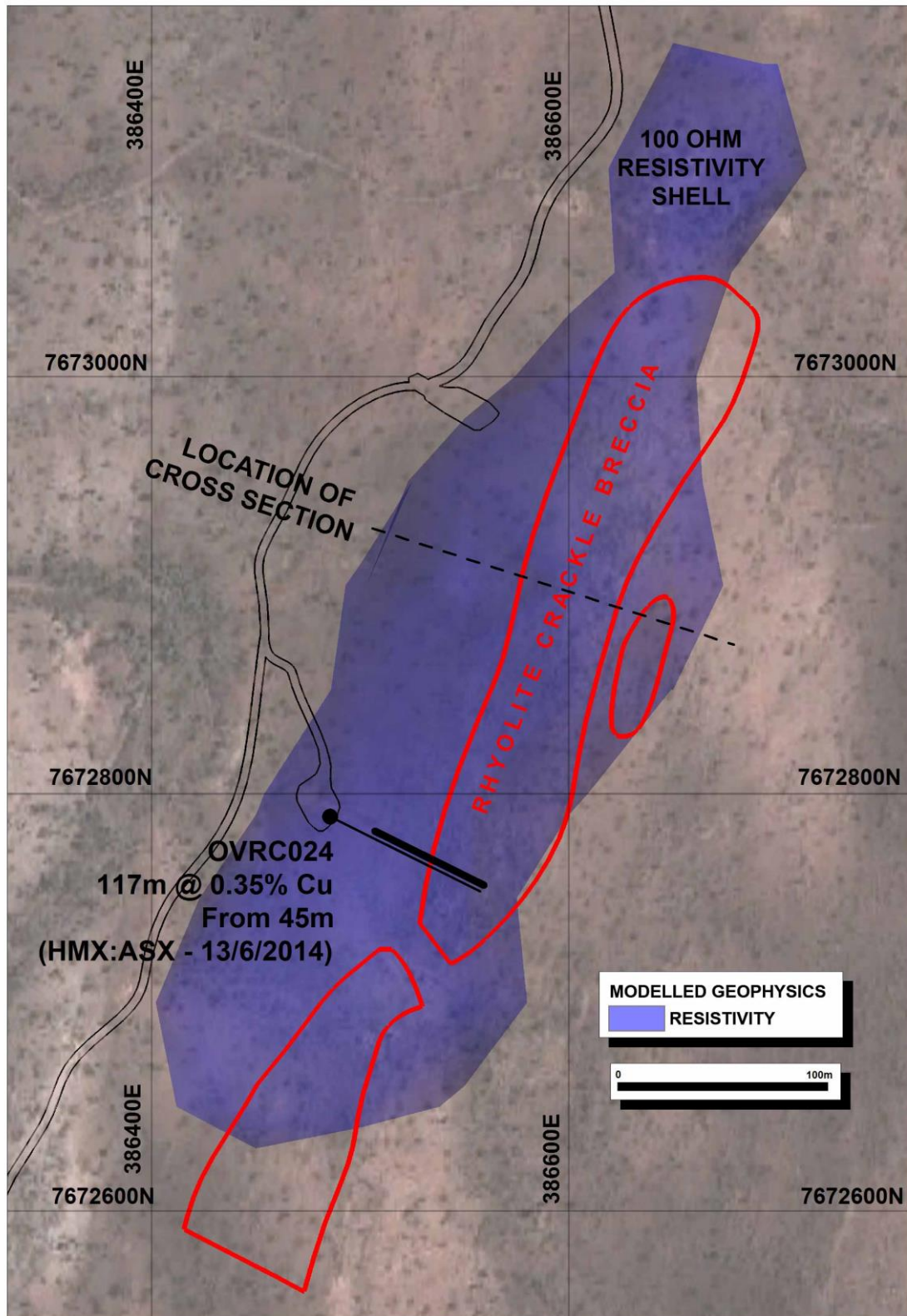
Andy's Hill and Overlander IOCG Targets with the IP survey extent (shown as a white outline)



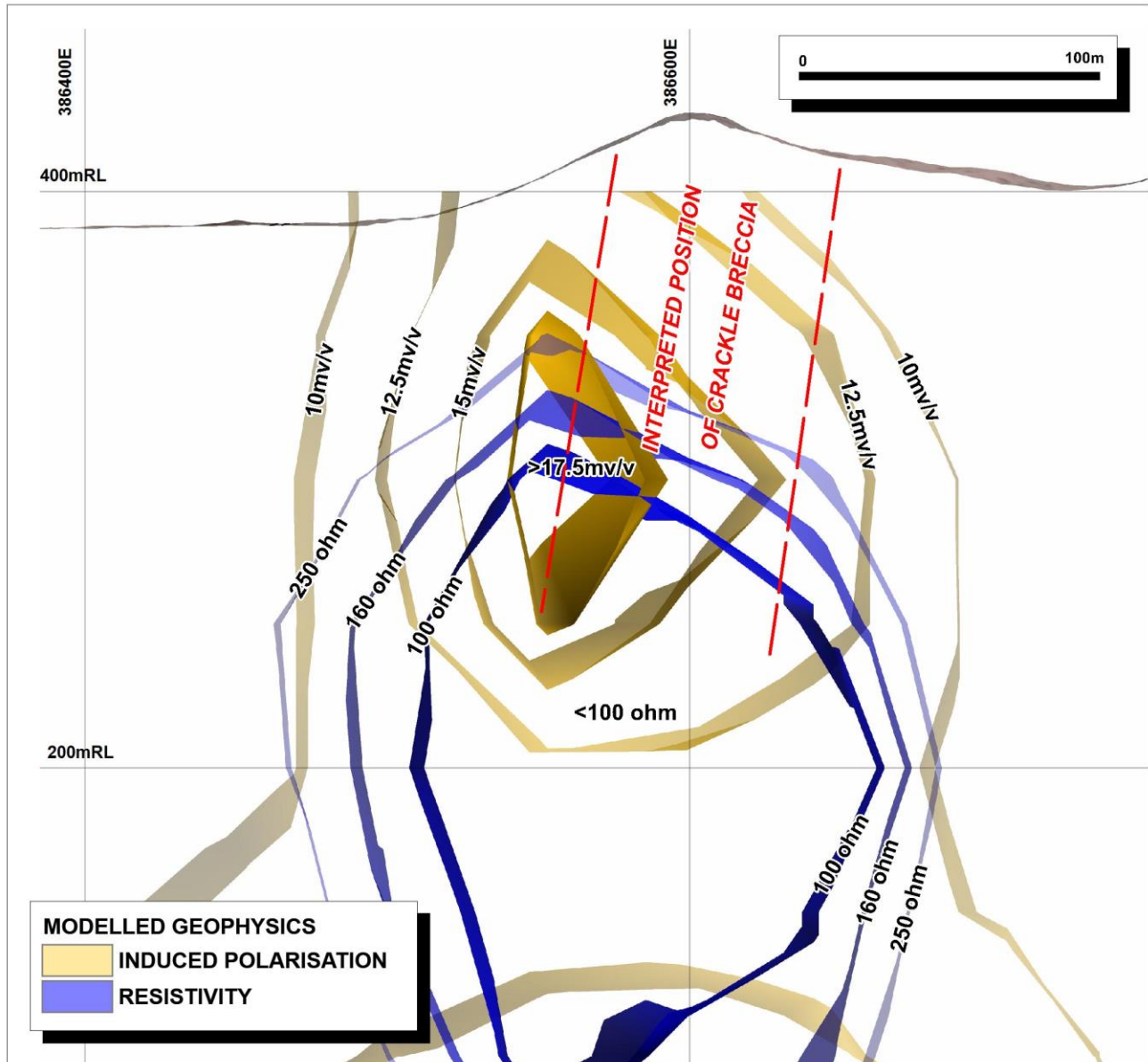
Andy's Hill Long Section looking West



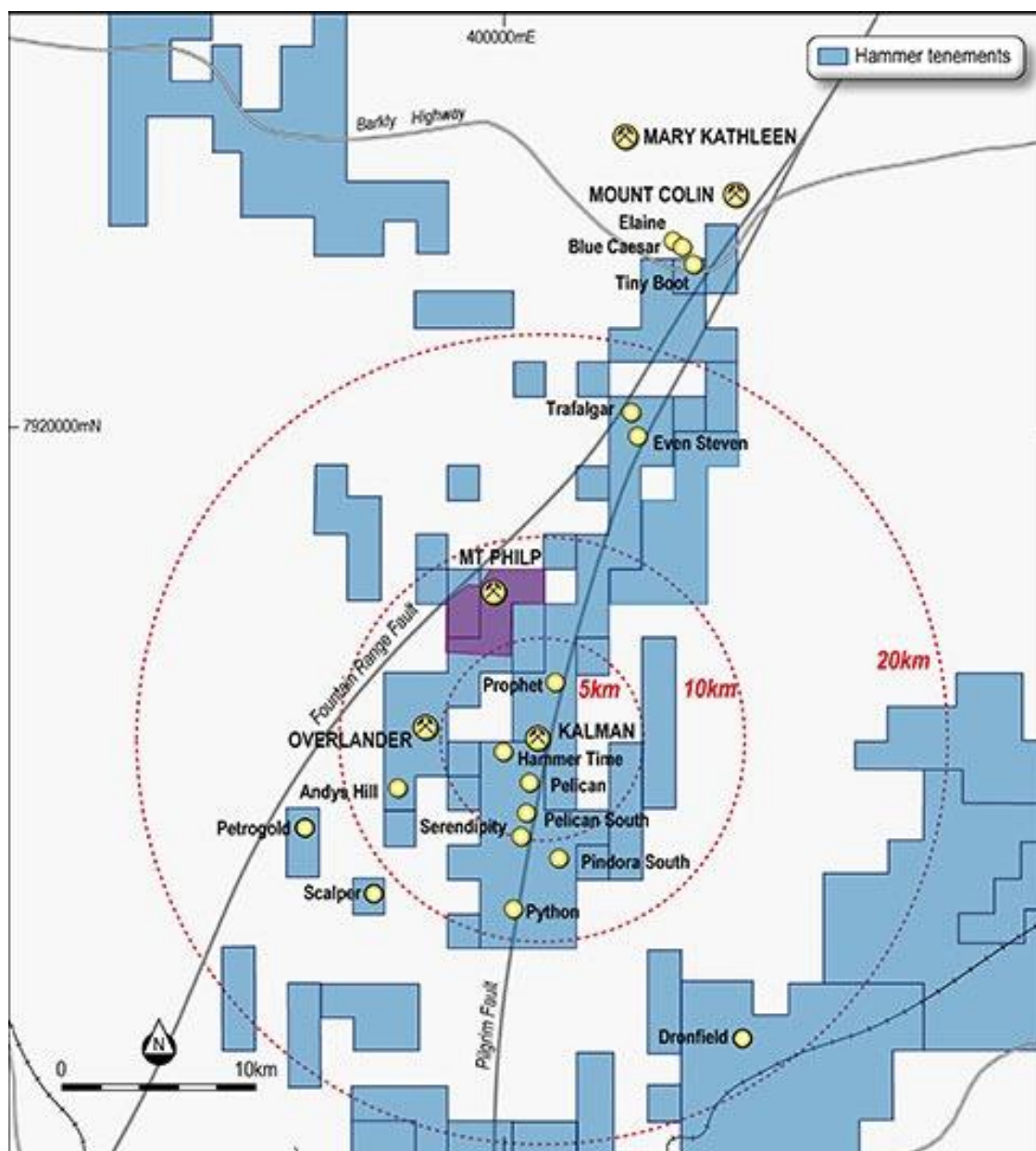
Andy's Hill Cross Section 7668900N looking North

This survey builds on previously modelled Gravity and Magnetic data which was completed in late 2014. Aspects of the Induced Polarisation survey (relating to Overlander North) were reported to the ASX on the 18th of March 2013. · The Induced Polarisation survey was conducted by Fender Geophysics. The oversight, audit and processing role is being fulfilled by Kim Frankcombe of ExploreGeo. · The geophysical survey type is Induced Polarisation and the layout of the survey (termed the “array type”) is termed Double Offset Dipole-Dipole. This configuration is one of many which are commonly referred to as 3D IP. · Specifically the array is composed of two receiver lines and a central transmitter line. All lines are oriented East-West. The receiver lines are “offset” from the transmitter line by 200m to the north and south. · The transmitter lines are spaced 600 meters apart. · The transmitter used is a GDD TxII 5000 watt unit and receivers used are GDD 16 channel units. · The survey uses an alternating current based on a 2 second cycle. · The survey was designed to totally cover the areas of interest outlined by
