Allotment of Securities

The Company has today confirmed the issue of 51,631,805 fully paid ordinary shares, being 22,263,623 shares under the Company's Share Purchase Plan, 23,190,922 shares under the shortfall placement approved by the Company's shareholders on 24 January 2020 and 6,177,260 shares as an additional shortfall placement under the Company's 10% placement capacity in accordance with ASX Listing Rule 7.1A. All these issues were at an issue price of \$0.022 per share.
