Hammer Metals Ltd (ASX:HMX) ("Hammer" or the "Company") is pleased to announce that it has finalised the reconciliation process for the final valid exercise notices from **HMXOD** option holders, resulting in the exercise of an additional 2,342,422 quoted options at \$0.03 each.

The Company confirms receipt of \$70,273 with respect to the exercise of these options.

The Company also confirms that 3,724,428 HMXOD options have lapsed unexercised.

The Company wishes to thank all those who participated in the exercise of the HMXOD options, which has been considered very successful. A total of 187,820,778 quoted options were exercised, representing over 98% of the total number of quoted options on issue. The exercise of options at 3 cents each has raised over \$5.6 million for the Company since June 2020.

About Hammer Metals

Hammer Metals Limited (ASX: HMX) holds a strategic tenement position covering approximately 2,200km² within the Mount Isa mining district, with 100% interests in the Kalman (Cu-Au-Mo-Re) deposit, the Overlander North and Overlander South (Cu-Co) deposits and the Elaine (Cu-Au) deposit. Hammer also has a 51% interest in the emerging Jubilee (Cu-Au) deposit. Hammer is an active mineral explorer, focused on discovering large copper-gold deposits of Ernest Henry style and has a range of prospective targets at various stages of testing. Hammer has recently acquired a 100% interest in the Bronzewing South Gold Project located adjacent to the 2.3 million-ounce Bronzewing gold deposit in the highly endowed Yandal Belt of Western Australia.
