

## Extension of Option Entitlement Offer Closing Date

Alderan Resources Limited (ASX: AL8) (**Alderan** or the **Company**) refers to the pro-rata non-renounceable entitlement issue of options on the basis of one (1) new option (**New Option**) for every two (2) fully paid ordinary shares (**Shares**) held by eligible shareholders at an issue price of \$0.001 per Option (**Entitlement Offer**) and the Prospectus announced on 6 September 2022.

The Company advises that the Closing Date of the Entitlement Offer to Eligible Shareholders has been extended by 7 days to 5pm (WST) on **Monday, 3 October 2022**.
