LA SIA S.P.A. AWARDED BEST IPO 2023 BY ASSONEXT

Rome, Nov. 16, 2023 - La SIA S.p.A. ("La SIA" or the "Company"), a company active in the engineering & design sector with a focus on critical infrastructure, listed on the multilateral trading system Euronext Growth Milan, is pleased to announce that it has been awarded "Best IPO 2023" at the AssoNEXT Awards, an event that celebrates excellence at Euronext Growth Milan organised by Asso Next, the Italian Association of Listed SMEs.

The August placement was a great success, with overall demand reaching 2.3 times the amount originally offered (equal to Euro 5 million).

This expression of interest had led the founding shareholders to increase the total countervalue of the placement to Euro 6 million, entirely as a capital increase as a result of their decision not to exercise the greenshoe option, which was originally provided for sale, allocating the entire amount of the fundraising to support the Company's strategic plan.

The minimum raising required by the regulation was entirely covered by primary foreign investors.

"We are very proud of this award." commented Maurizio Ciardi, Chairman and CEO of La SIA, "The listing marked an important turning point in our company's growth path; the trust accorded to us by investors, especially foreign ones, is a great source of pride and an ever-growing commitment. We would like to thank AssoNEXT for the award, the entire La SIA team and the advisors who have supported us in these months".

The Company recently reported the following financial results as at 30 September 2023:

- Value of Production: €11.1m compared to €9.7m in September 2022 (+13.7%);
- NFP: €4.0m (cash) compared to €1.1m (debt) in December 2022;
- Backlog: €34.9m compared to €29.2m in September 2022 (+19.8%)
- Guidance 2023 and Dividend Policy 2023-2025 with a Payout Ratio of 75% on net profit confirmed
