New Issue Announcement – Share Placement - Appendix 3B

ShieldLiner Limited is pleased to announce the issue of a further 1,320,000 shares at an issue price of 25 cents per share to private investors and several existing shareholders including National Power Services Pty Ltd who continue to maintain a 10.57% interest in the company.

The issue is at a significant premium to the weighted average price of share sales on the ASX in the period from 5 May 2005 to 20 July 2005 of 19.7 cents and is a reflection of the confidence of the investors in the future of the ShieldLiner System, a unique patented and patent pending technology for the in situ repair and rehabilitation of both above and below ground pipes in a range of industries. The funds raised will be used for working capital purposes and will supplement the company's existing strong working capital position. As a consequence of the placement the company is well placed to accelerate a number of planned refinements to the ShieldLiner System and to pursue a number of other opportunities in the trenchless technology industry.

Based on the company's existing working capital, prior to the placement the company already had funding for the next two years planned research and development, operating costs and overheads. The company expects to commence deriving revenues from the ShieldLiner System during the 2006 financial year.
