ASX Announcement

Grant of Options to Employee & Director Options Cancelled

The company is pleased to advise that it has agreed to grant a total of 20,000 options to Dr Luca Amato, the company's in house materials engineer pursuant to the provisions of the company's employee share option scheme ("the Scheme").

The grant of the options is in recognition of Dr Amato's efforts in refining off the shelf resin systems to make them suitable for use with the ShieldLiner system and his work on materials and materials testing.

The terms of the Scheme have previously been approved by shareholders and these are the second tranche of options issued to employees pursuant to the Scheme. A total of 220,000 Options have now been issued pursuant to the Scheme. Options representing up to 5% of the company's capital can be issued under the scheme. The exercise price of the options is 30 cents and the term of the options is five years from 1 January 2006.

Mr AM (Tony) Zuiderwyk, a non executive director of the Company recently requested that the Company cancel the 200,000 director options previously granted to him. The request arose as a consequence of a review by Mr Zuiderwyk's employer of his employment arrangements. The Company has now entered into a deed with Mr Zuiderwyk to cancel the options.

We have attached the applicable Appendix 3B new issue announcement in respect of the grant of the options to Dr Amato and that document also reflects the reduction in Options on issue as a consequence of canceling the Options previously granted to Mr Zuiderwyk.
