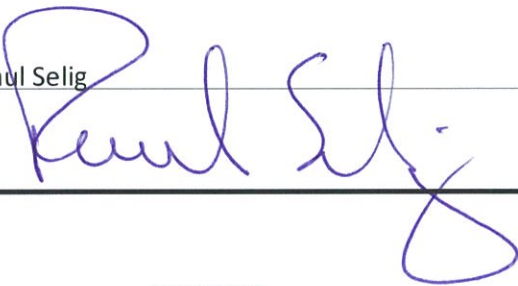

DIRECTIONS
