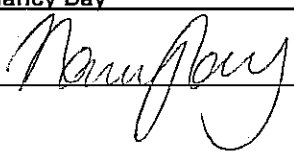

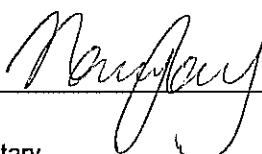

DIRECTIONS

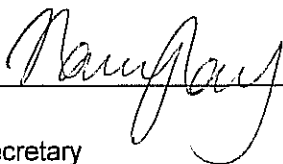
