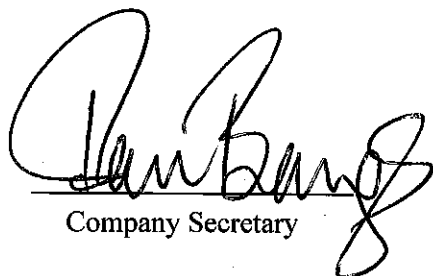
## Quotation Agreement
