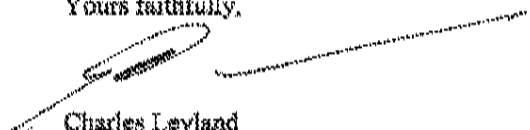

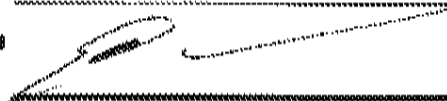

DIRECTIONS
