NON-RENOUNCEABLE PRO RATA ENTITLEMENT OFFER – NOTIFICATION OF SHORTFALL

Firestrike Resources Limited (ASX: FIE) (Company) is pleased to advise that the Company's entitlement offer announced on 17 October 2013 closed at 5pm (WST) on 15 November 2013 (Entitlement Issue).

The Entitlement Issue raised AUD \$18,458 before issue costs.

The Entitlement Issue was strongly supported by the Company's shareholders, with applications subscribing for 9,229,092 options representing a take-up of 58%.

The Company will endeavour to place the shortfall of 6,770,908 options.

The Company expects that the new Firestrike options will be allotted, and holding statements despatched to shareholders, on or before 22 November 2013.
